Big picture talking points on agriculture (please let me know if you would like some filler information on any of these points):

Governor Haley is not requesting federal appropriations for any industry, not just agriculture.

We recognize agriculture is a unique industry, and thus is treated uniquely by the federal government through commodity programs and federally subsidized crop insurance.

Understanding that insurance does not make everyone whole, insurance was available and unfortunately many farmers did not take full advantage of the coverage options.

Governor Haley has been and will continue to work with USDA to expedite the crop insurance claims process and emergency loan processing.
