USPS Records First Profit in Five Years as Obama Calls for Shedding 12K Postal Jobs

Government Executive: The U.S. Postal Service turned a profit in a financial quarter for the first time in five years, though President Obama still proposed the agency slash 12,000 employees in his fiscal 2017 budget.

USPS posted a net income of \$307 million in the first quarter of fiscal 2016, the first such gain since the fourth quarter of fiscal 2011. Profits grew \$1.1 billion over the same period last year, when the Postal Service lost \$754 million.

Operating revenue ticked up 3.3 percent to \$19.3 billion between Oct. 1 and Dec. 31, 2015, driven largely by a record volume of package delivery.

The 2017 budget, which was released on Feb. 9, estimates that any raise less than 2.1 percent would be the eighth-consecutive annual increase that came in below the Employment Cost Index, which measures the cost of labor.

Obama's final budget proposal calls for \$4.15 trillion in spending

The Washington Post: President Obama sent the final budget proposal of his presidency to Congress on Tuesday, a \$4.15 trillion package that will mark the closing rounds of a long-running fiscal battle with Republicans in Congress over the nation's spending priorities.

The proposal would boost total spending by 4.9 percent, mainly as a result of increases in mandatory programs, most notably Social Security, and a rise in interest payments on the national debt. In keeping with the two-year budget deal struck with Congress in December, the president requested only a slight increase, less than 1 percent, in discretionary spending programs overall, though Republicans still accused him profligate spending.

Chinese Cyberspies Pivot To Russia In Wake Of Obama-Xi Pact

InformationWeek: TENERIFE, SPAIN – Kaspersky Security Analyst Summit 2016 – Cyber espionage attacks by Chinese advanced persistent threat groups against Russian targets have increased by 300 percent in the past two months, according to a top security expert with Kaspersky Lab.

Costin Raiu, director of the global research and analysis team at Kaspersky Lab, says his firm's researchers witnessed a dramatic drop in Chinese-speaking APTs going after US and UK organizations' intellectual property in September after President Obama and Chinese president Xi Jinping came to a historic agreement not to conduct cyber spying attacks for economic gain. Kaspersky Lab refrains from confirming the actual actors behind advanced groups such as nation-states, so it refers to these attackers as "Chinese-speaking" cyber espionage groups.

White House Wants to Give Agencies New Pot of Money to Upgrade Legacy IT

Nextgov: The White House is seeking Congress' help to establish a multibillion-dollar fund that federal agencies could use to upgrade aging computer networks prone to cyberattacks and system failures.

As part of a planned Cybersecurity National Action Plan announced today, the Obama administration wants permission to establish a \$3.1 billion revolving fund that will help agencies transition away from so-called legacy IT toward more modern options, such as cloud computing.

The New York Times: BOSTON — For thousands of college hopefuls, the stressful college admissions season is about to become even more fraught. The College Board, which makes the SAT, is rolling out a new test — its biggest redesign in a decade, and one of the most substantial ever.

Chief among the changes, experts say: longer and harder reading passages and more words in math problems. The shift is leading some educators and college admissions officers to fear that the revised test will penalize students who have not been exposed to a lot of reading, or who speak a different language at home — like immigrants and the poor.
