Item #20: Are you or any company in which you have a controlling interest delinquent in any local, state or federal taxes:

Yes, in 2013 I had to close down Rogers Traylor Company, LLC, due to an ongoing divorce. At this time, I was in charge running the Karl Sitte Plumbing Company, Inc. Due to the downward spiral of both companies, I was having to borrow money from Rogers Traylor to make Sitte Plumbing payroll. January 26, 2013, my estranged wife, Sabrina Rogers, terminated my employment with Karl Sitte Plumbing Company. At the present time, the money owed to Rogers Traylor Company was never repaid from Sitte Plumbing. Therefore, I ended up owing the SC Dept of Revenue \$26,000 +/- for sales tax. Now I am in process of working out a payment arrangement with the SC Dept of Revenue.

Item #23: I have a lawsuit against Camping World, for a motor home that I purchased in 2006 that was not working properly. Jake Moore, Attorney, is handling this case.
