WILD FOREST FIRES ARE A TRADITIONAL PROBLEM. MODERN FIRE FIGHTING TECHNOLOGY IS IMPROVING, BUT THE CONTINUED MOVEMENT OF PEOPLE INTO THE SOUTH, THE GROWING NUMBER OF PEOPLE USING THE FOREST AND THE TREND TO BUILD HOMES, AND DEVELOPMENTS IN PROXIMITY TO THE FOREST, INCREASE THE CHANCES FOR FOREST FIRES AND INDEED THE RISKS OF FINANCIALLY DEVASTATING WILDFIRES. ADDITIONAL PERSONNEL AND FUNDING ARE REQUESTED FOR AN INTENSIFIED EFFORT TO REDUCE FOREST FIRE OCCURRENCE AND FIRE LOSSES.

\$1,331,731 IS REQUESTED FOR REPLACEMENT OF MECHANIZED EQUIPMENT ESSENTIAL TO THE FOREST FIRE PROTECTION PROGRAM; \$95,371 FOR REPLACEMENT OF RADIO COMMUNICATIONS EQUIPMENT WHICH MUST BE RELIED UPON TO PERFORM FIREFIGHTING OPERATIONS EFFICIENTLY AND EFFECTIVELY TO AVOID SERIOUS INJURIES AND LOSS OF LIFE; AND \$32,500 FOR PROCESSING AND FABRICATING NEW MECHANIZED EQUIPMENT WHICH MUST BE ADAPTED TO SPECIALIZED FIRE SUPPRESSION ACTIVITIES.

THE REQUESTED FUNDS WILL BE UTILIZED TO PROVIDE PART TIME CREW MEMBERS FOR FOREST FIRE SUPPRESSION EQUIPMENT OPERATORS THUS INCREASING BOTH THE SAFETY AND EFFICIENCY FACTORS. SUPPRESSING HAZARDOUS FOREST FIRES ALONE AND AT ALL TIMES OF THE DAY AND NIGHT PRESENTS AN UNDESIRABLE SITUATION THAT COULD BE AIDED CONSIDERABLY WITH THE ADDITION OF A PART-TIME CREWMAN.

THIS COVERS THE EXPENSES OF 2 PROFESSIONALS AND SECRETARIAL SUPPORT TO ASSIST PRIVATE LANDOWNERS IN THE DETECTION, IDENTIFICATION, AND SUPPRESSION OF FOREST PESTS.

REQST: 005

IMPLEMENTATION OF FOREST RENEWAL PROGRAM TO THE TWO THIRDS LEVEL INCLUDING INDUSTRY'S ASSESSMENT AT RATIO OF \$4 TO \$1 OF APPROPRIATED MONEY WILL REDUCE THE REGENERATION SHORTFALL (LANDS HARVESTED AND NOT REFORESTED) BY 7,000 ACRES.

THIS WOULD GENERATE \$47,370,000 VALUE ADDED TO THE STATE'S ECONOMY.

THE COMMISSION IS REQUESTING \$236,152 TO ASSIST WITH DEFICIENCIES IN TRAVEL AND TELEPHONE BUDGETS.

IT IS IMPERATIVE THAT ADEQUATE FUNDS BE MAINTAINED TO PROVIDE TRAVEL FOR FOREST MANAGEMENT SERVICES AND ASSISTANCE IN PREVENTING AND CONTROLLING FOREST FIRES.

IT IS ALSO A NECESSITY THAT A RELIABLE TELEPHONE SYSTEM BE MAINTAINED TO PROVIDE THE PUBLIC A COMMUNICATIONS LINK WITH THE COMMISSION TO REPORT FOREST FIRES, NOTIFICATION OF INTENT TO BURN, AND REQUEST FOREST MANAGEMENT SERVICES.

REQST: 007

A POSITION TO PROMOTE SECONDARY MANUFACTURING OF LOW TIMBER PRODUCTS AND THE USE OF S.C. TIMBER NOT NOW BEING UTILIZED.

IT WOULD ASSIST THE STATE DEVELOPMENT BOARD IN THE LOCATION AND AVAILABILITY OF RAW MATERIALS FOR NEW LOCAL, NATIONAL, AND INTERNATIONAL MARKETS.

TWO ADDITIONAL URBAN FORESTERS ARE NEEDED TO MEET THE URBAN FORESTRY NEEDS OF CITIZENS LIVING IN URBAN AREAS.
