The attached is an example of the Notice of Termination emailed late yesterday to all four Qualified Providers. A hard copy was also postal mailed certified to each Qualified Provider.

There are several reasons why the Department of Mental Health chose at this time to terminate this contract and provide needed PAP services by other means. The specifics vary by local Community Mental Health Center, and in instances, even by local offices. The Department of Mental Health does not expect to need a similar contract in the immediate future.
