Securing South Carolina's Infrastructure Through Investment

Governor Nikki Haley, 2013 State Of The State: "The Answer To Our Infrastructure Problems Is Not To Tax Our People More, It's To Spend Their Money Smarter."

During a Thursday afternoon press conference, business leaders from across the state praised Governor Nikki Haley's plan to invest additional anticipated revenues into strengthening state infrastructure. The governor's executive budget, released in December 2012, invests more than \$90 million in projected new funding for transportation in FY 2013-14.

Tomorrow, based upon the strong revenue collections which South Carolina has had to-date, the

Board of Economic Advisors (BEA) is going to raise its revenue estimate and recognize close to \$100 million in new money. Governor Haley is urging lawmakers to use it to fix transportation infrastructure.
