Gov. Nikki Haley said she knew there had been problems at the Richland County Department of Social Services last year but when a 5-month-old boy died last month who had been sought for weeks by caseworkers, Haley said she had to act.

**Note:** "That's when I thought, all right, something's got to give," Haley told The Greenville News. "That's when I went into the DSS offices and said, 'Let's look at this again.' "

Gov. Nikki Haley is taking a hands-on approach with the Department of Social Services, implementing changes on a local level, which might lead to statewide modifications in the future. Haley said Tuesday changes are needed at the Richland County DSS office following a case in April in which an infant died while a DSS staffer was searching for his family.

Gov. Nikki Haley unveiled a plan Tuesday to improve caseloads and child-welfare services at the Department of Social Services' Richland County office. A short-term intervention team and new hires, including more caseworkers, are part of the plan, Haley said in an interview with The State.
