Chairman Robert Williams called the meeting of the South Carolina Athletic Commission to order at 3:00 P.M., on Wednesday, April 16, 2003, with a quorum present via conference call at the Department of Labor, Licensing & Regulation, Room 104-09, 110 Centerview Drive, Columbia, South Carolina. Other Commissioners participating in the meeting included: Vice-Chairman George Cox, Myrtle Beach, Paul Kennemore, Greenwood, Commissioner Luther A. Bradley, Hemingway, Commissioner Clyde Jones, Camden and Commissioner John R. Robertson, Irmo.

1. Oliver McCall is 37 years old and it will require a unanimous consent by the Commission in order for him to be licensed as a boxer in South Carolina.

2. After review of the submitted information, does the Commission approve the McCall v. McKinney fight for April 24, 2003?

Following discussion, a roll call vote of the Commission was unanimous to license Oliver McCall as a boxer in South Carolina. Mr. Cox moved to approve the bout on April 24, 2003 at the PLEX in Charleston, South Carolina, with no more than 10 rounds. Mr. Bradley seconded the motion, which unanimously passed.
