Governor Nikki Haley

I am hopeful that with your help we can overcome an error that has occurred to my release date from the Department of Correction of S.C. (DOC).

I was convicted of (2) two separate drug related offenses in Sep. of 1994. In Horry County I was sentenced to (25) twenty five years, in Sumter County I was sentenced (30) thirty years **both sentences were running concurrently**).

On the 25 year sentence I was supposed to have been released in Sep- of 2007. On the (30) year sentence from Sumter County, I was due to be released on February-1-2010. However, (20) days prior to be released I was called to speak with Ms. Mixon Chief of Classification at Ridgland Corr. Inst., who informed me that the (DOC) has deemed it in their power to turn a **(non-mandatory)** sentence into a **(mandatory)** (25) twenty five years sentence).

I was told that had been an error made in the records in the (DOC) and I have had and would have to service an additional (10) ten years before I could be released.

I took the (DOC) to Court for an evidentiary hearing (P.C.R.) and I won my case.

The Judge ordered to Mr. Michael Stobbe, The Chief of Inmate Records at Head Quarter in Columbia S.C. to correct my release date from 2020 back to the original date of (February-1-2010).

Mr. Stobbe agreed that my release date should in fact show to be February-1-2010 and would correct my release date when he returned to his office at Head Quarter .

Governor Haley, what Mr. Stobbe did when he returned to his office was change my **sentence (start date)** from 1994 when the mandatory sentence was out of the Bill, to 1995 when the Bill for mandatory sentence was reinstated.

I have the Court Order where the Judge ordered Mr. Stobbe to correct my release date. I have the Court transcript where Mr. Stobbe admits that my release date should in fact reflect (2010) and not (2020).

I have all documentation from the Courts as well the (DOC) that will support all claims that the (DOC) has been and still holding me long past my release date.

Governor Haley, I have no idea how and error of this magnitude can continue to go unresolved but I am almost (5) years past my release date and I have tried everything I can think of to get this situation resolved. Somebody need's to take responsibility for this situation and help me get back to my family where I rightfully belong.

I know that I commit a crime that I have paid for.

I am a (71) year old diabetic man with heard disease and a very sever back problem's and I just want to go home where I belong.

As I have said I have (all) documentation and paper work that will support all that I have told you. Can you help me ?. I can not get one person here to look at one single piece of evidence that I have and no one seem's to care about the Judge's Court Order.

Is there any way you can help me ?. or at least point me in the right direction of someone that may help me put all of this behind me.

Please any input would be appreciated may God help you.
