

1. Investigate opportunities for contract maintenance, evaluate costs, and implement a program of expanded, cost-effective contract maintenance work.
2. Increase construction obligations in the SHIMS program by 25 percent over previous year. Continue to obligate all available federal-aid funds (approximately \$120,000,000). Reduce average time from programming a letting date to 18 months per item in "C" program.
3. Expand maintenance program and develop initiatives for construction projects to include wildflower and other natural vegetation to improve highway aesthetics.
4. Review department policies and procedures which concern budget, disbursements and collection of funds and revise procedures as necessary to maintain compliance with state and federal laws and to enhance efficiency.
5. Continue to work with local transportation authorities and agencies in order to increase local financing for public transportation.
6. Complete the design of a pending statewide promotion/education program for public transportation by April 30, 1991.
7. Facilitate the implementation of the new DBE/WBE State legislation effective July 1, 1990 and coordinate with the various divisions and organizations to develop required regulations to administer the provision of this Act.
8. Conduct a feasibility study of the ON-The-Job Training Supportive Services Program to determine its effectiveness for continuation as Federal funds have been terminated.
9. Computerize all workers compensation files in order to increase the efficiency in determining the type of injury, past compensation, medical payment, etc. as well as maintaining pending claims.
10. Insure security in Driver Records area by implementing changes in procedures.
11. Employ part-time help during lunch hours in the department's vehicles and driver services offices in order to maintain maximum service.
12. Improve recruitment efforts by attending more campus career fairs, contacting more minority campuses and female organizations in hopes of recruiting more minorities and females for areas of underutilization and increase minority and female applicants by advertising in Minority Recruiter, minority campus newspapers, and with female organizations.

13. Aggressively pursue the acquisition of available funds from state and federal sources for enhancement of highway safety efforts in the agency.
14. Move long distance data communication to the State Data network. This network was established in Spring 1990 and allows participating agencies to share in long distance communication costs. We anticipate a reduction in our long distance cost of about 30% from \$26,000 a month to \$18,000 a month.
15. Perform a complete audit of a \$10.2 million contract with Figg & Muller Engineers, Inc. Utilize sampling techniques that require testing of a small percentage of the total costs.
16. Develop a system of computer networking from each patrol district to the patrol headquarters to allow the daily retrieval of information from daily reports and arrest reports to aid in developing enforcement needs for a particular area.
17. Continue to improve public relations through training of each officer and public speaking and community relations through the annual patrol in-service training program.
18. Develop strategies that will enable the agency to obtain increased funds with the assistance of South Carolina for Better Transportation.
