Austin,

I thought I had sent this prior to the New Year, I just saw it in draft in my email. Apologies for the delay. We are starting to get inquiries on this topic. Most recent is Senator Davis' office in Beaufort, which has received multiple questions regarding the Real Act Id and our state driver's licenses. We haven't

responded yet to his inquiry pending any feedback on this document.

Per your request attached is a short rundown on where we are with respect to REAL ID in SC. The Bottom-Line is we have met most requirements but in order to be in compliance, as a state, we would need to 1. Change the expiration of our non-commercial licenses and IDs to a max of 8 years (requires legislation). 2. Require all personnel applying for a new or renewed license or ID who haven't renewed since 2010 to bring ID's, birth cert, SSN, etc. to the DMV for verification. 3. Requires us to mark our ID and DL with a HLS approved marking (Gold Star or variant). 4. Requires rescinding 56-1-85 (requires legislation).

If you have questions, fire away. I've cc'd Annie Phelps who has worked REAL ID since the Federal Legislation came out.
