This survey gathered data on key topics impacting I&R/A agencies, including referrals and service needs, use of social media, partnerships and system building, standards and quality assurance, training and certification, private pay, and Medicaid services. Inclusion of Children with Disabilities in Early Childhood Programs

The United States Departments of Health and Human Services and Education released a policy statement on September 14, 2015, that declares that all children with disabilities should be allowed access to "inclusive high-quality" early childhood programs, "where they are provided with individualized and appropriate support in meeting high expectations." Presently, children with disabilities and their families face difficulties in accessing these programs that are available for their peers. The policy statement offers a vision of what states, local educational agencies, schools, and public and private early childhood programs can do to make early childhood programs more inclusive.

Webinar: Meeting the Evidence-based Requirements of OAA Title IIID

The Administration for Community Living (ACL) and the U.S. Department of Health and Human Services are sponsoring a webinar on meeting the evidence-based requirements of Older Americans Act (OAA) Title IIID. This webinar will teach participants about the requirements of the OAA Title IIID and how to meet them. The requirement to use Title IIID dollars for only the highest-level evidence based programs will go into effect nationally on October 1, 2016. Highest-level programs meet the following criteria: Demonstrated through evaluation to be effective for improving health and well being or reducing disease, disability, and/or injury among older adults; proven effective with older adult population, using experimental or quasi-

experimental design; research results published in a peer-reviewed journal; fully translated in one or more community site(s); and includes products for dissemination that are available to the public. The webinar will include presentations from states and AAAs that are meeting the requirements and they will also share promising practices for overcoming challenges. The webinar will take place on **Thursday, October 29, 2015, from 2:00 p.m. to 3:30 p.m. ET.**

Centers for Medicare and Medicaid Services

CMS Releases Final 2016 Medicaid Managed Care Rate Development Guide

On Thursday, the Centers for Medicare and Medicaid Services (CMS) released the final [2016 Medicaid Managed Care Rate Development Guide](#). This guide is for states to use in the development of any Medicaid managed care rates with rating periods starting on or after January 1, 2016. CMS released a draft of the guide in June and sought comments from the public through the Federal Register. The final guide includes input gathered from the public comments including: Changes around the administrative load development; clarity on defining the types of managed care plans; when a legally mandated change should be incorporated into the rates; and clarification on the types of supporting documentation expected. States and their actuaries should follow this guide in development of their actuarial certifications in order to streamline the review process.

Final Federal Health IT Strategic Plan 2015-2020 Released

On Monday, the U.S. Department of Health and Human Services' Office of the National Coordinator for Health Information Technology (ONC), in collaboration with over 35 federal partners, released the Federal Health IT Strategic Plan for 2015-2020. The plan represents the strategy of the federal offices that use or influence the use of health information technology. The plan hopes to improve the infrastructure of health IT and provides a blueprint of strategies for federal partners to implement to ensure a responsive and secure health IT system. The strategic goals of the plan are to: Advance person-centered health and self-management; transform health care delivery and community health; foster research, scientific knowledge and innovation; and enhance the United States health IT infrastructure.

The National Council on Independent Living's (NCIL) CIL-NET is sponsoring a webinar on an introduction to the new indirect cost rate requirements for Centers for Independent Living (CIL). This past July, the U.S. Department of Health and Human Services (DHS) notified all Centers for Independent Living receiving federal funds that they would need to submit an indirect cost rate proposal instead of the cost allocation plans required by the US Department of Education. This webinar will teach CILs about the new requirements set by DHS. The webinar costs \$75.00 per
