USDA Proposes New Ways to Help Meet Nutrition Needs of Low-Income, Homebound Seniors and People with Disabilities

In July of 2015, USDA issued a proposed rule that would allow homebound, older Americans and disabled persons to use their SNAP benefits to purchase groceries through purchase and delivery services run by government agencies and non-profit organizations. LEGISLATIVE REPORT

Progress For Bill To Bolster Medicare Patients' Hospital Rights

On July 27, 2015, the U.S. Senate unanimously approved legislation requiring hospitals across the nation to tell Medicare patients when they receive observation care but haven't been admitted to the hospital as inpatients. The NOTICE Act, short for "Notice of Observation Treatment and Implication for Care Eligibility," would require hospitals to provide written notification to patients 24 hours after receiving observation care, explaining that they haven't been admitted to the hospital, the reasons why and the potential financial implications.
