

TOPIC: INTERNATIONAL DRIVE

I am writing to you, along with others, to express my disappointment as to the status of International Drive. I recently received from Lisa Bourcier, who I have been in constant contact with, an update that recently was published by Michael Smith on May 4, 2015. I have also been in touch with the Army Corp of Engineers and spoke to Mr. Fennel who told me that it is being closely looked at. I must be honest and tell you that I informed Mr. Fennel that it has been on the agenda for 7 to 9 years and by now they should be able to give the necessary permits to get this project started.

Why is it that in 2012 Rep. Nelson Hardwick, who unfortunately I can't turn to given his circumstances, had a deal with the SC DNR about the bear bridge. Why has this changed? I also see that the County has to demonstrate how they will mitigate any impacts on the wetlands. Do they have a plan in place?

This project has been in the works for quite some time and we the residents on 90 do not understand why all of what is being requested by the Army Corps of Engineers has not been provided before now. All the bases requested to be covered by Mr. McBride, this isn't the first time these request have been made.

This road is not only a convenience road but a necessary exit road in case of emergency. Do I need to refresh everyone's memory about the horrific fire a few years back? We need an exit aside from 22 and 501. What has to happen, a catastrophe before this road finally begins.

I turn to you, our elected official, to please put the necessary pressure on to get this project started. We are all quite frustrated with the excuses over the years and would like a response and update.
