Chairman Dan Rhodes called the meeting to order. The Reverend Jack Crandall gave the invocation.

Sheriff E.E. Cooley stood and lead with the pledge of allegience to the flag.

Welcome and special introductions were presented by C.J. Burdette, Clerk of Court.

Mr. David Hooper proposed a resolution (#278) naming the former office of the late Chief Magistrate Lawrence L. Whitfield the LAWRENCE L. WHITFIELD BUILDING. He then moved that the resolution be approved. Mr. Beebe seconded. Vote was unanimous.

Senator T. Ed Garrison presented the widow of Lawrence Whitfield with a plaque containing a gavel.

Mr. Jimmy Cox then unveiled a portrait of the Honorable Judge G. Ross Anderson, which will hang in the Anderson County Courthouse.

Council recessed for 20 minutes. Refreshments were served.

Chairman Rhodes called the meeting back to order at 5:05 p.m.

On the motion of Mr. Cox, seconded by Mr. Hooper, Council voted unanimously to amend the agenda to discuss the Airport Commission and the Civic Center Ordinance.

On the motion of Mr. Hooper, seconded by Mr. Cox, Council voted unanimously to appoint Mr. Melvin Jewel to the Airport Commission.

Mr. Mullinax asked for approval of third reading on Ordinance #168 (Civic Center Authority) as presented to Council on second reading. Mr. Hooper moved that the Ordinance be approved. Mr. Cox seconded. Vote was unanimous.
