## Congress looks to cap federal Medicaid spending

NCOA has learned that Congress is looking to restructure the way Medicaid is funded as part of the Affordable Care Act replacement proposal. Medicaid is a critical program for low-income seniors, paying for long-term care and Medicare cost-sharing. Currently, states are guaranteed to receive federal matching funds that cover actual Medicaid cost growth. Under the new proposal, states would face a “per-capita cap” that limits the federal contribution. Caps would be based on a preset formula and would no longer cover actual expenses. While this would make federal spending more predictable, it also would shift the risk of rising costs onto states. NCOA and other advocates are concerned that this would lead to cuts in services for low-income seniors and other vulnerable populations.
