We were in touch almost two years ago regarding the transfer of property from the Navy to the City of North Charleston. You may have received a notification from the either The Navy or the General Services Administration GSA regarding the property. The notification is a formality of the Finding of Suitability for Early Transfer (FOSET) process. The City has been in negotiations with the Navy, SCDHEC and the GSA in Washington regarding this transfer

of property. The transfer was approved by the GSA and the Governor must sign the FOSET documents in order for the final transfer to occur. Are you aware of any documents that may have come across your desk regarding the Marine Corp property at the Charleston Air Force Base to the City of North Charleston?
