We are the parents of a 22 year old daughter that we love very much. Our daughter and her care have become our entire life. She cannot see, talk, or walk. She has been diagnosed with very brittle bones. She is and always will be a child. The only time she ever cries is when she is in pain.

She does receive Medicaid. She has many, many health issues. Currently our daughter is on a waiting list for dental surgery. We have been told that there are no emergencies. The waiting list is over 6 months long. She has 2 months to go. We have been told that Palmetto Richland Hospital is the only facility in S.C. participating. WHY? It is our understanding this hospital performs only 2 dental procedures a week. There are thousands of special needs children in SC.

Our daughter cries a lot now. She has to be administered pain injections and IV antibiotics due to the severe infections she developed. Does anyone have any MERCY anymore?

Whatever you can do with this Crisis in the Medicaid program please help. Other children are waiting just like our daughter. She should not be told by S.C. Medicaid to go to an out of state hospital to get care. We tried. They have waiting lists also. She lives in SC. You represent her needs. She needs help and mercy today.

Dear Mr. And Mrs. Edge:

Your email dated January 3, 2007, regarding the need for dental services for your daughter, Susan, has been forwarded to the South Carolina Department of Health and Human Services (SCDHHS) for review. We welcome the opportunity to assist you with these issues.

You have spoken several times with Ms. Shirley Carrington, Supervisor for Dental Services regarding Susan's dental circumstances and indicated to her that only Palmetto Richland Hospital can provide dental services to Susan, but their waiting time is excessive. Per your telephone conversation with SCDHHS staff on today, you indicated that the appointment with Palmetto Richland Hospital is scheduled for March 7.

On the recommendation of our Medicaid Dental Consultant, we are enclosing a list of enrolled Oral and Maxillofacial surgery Medicaid providers in Horry County and surrounding counties who may be able to examine, diagnose and develop a plan of care for Susan prior to her scheduled appointment with Palmetto Richland Hospital. The plan of care will assist in determining the services that Medicaid covers for Susan. Adult beneficiaries enrolled in the MR/RD waiver program are eligible for the same comprehensive covered dental services as beneficiaries under the age of 21.

We appreciate your bringing this matter to the attention of SCDHHS. If you choose to make an appointment with one of the Medicaid enrolled providers in Horry County and would like additional assistance in scheduling the appointment, please contact Ms. Carrington at (803) 898-2563 for assistance.
