Britt, How have you been?" Shaking my hand. I Never saw or spoke to this man before. I Wasnt there during the yard sale And knew nothing, I was going to leave Mr White said NO And for me to sit down he wanted me to see A statement from the said Jackle Hallofeld reads Jackle, Bobbieann, Jackies sister, And sisters boyfriend had been doing Meth (delivered by Jackie And Terry to My house) in Master bath. it went



on to Read, Did Frank know "No And I pray he doesn't see this, he'll be heart broken" Signed Jackie. Who per Deot. White was in Jail in Hickory N.C. on Meth Charges. Mr White goes on to tell how Mean the Sisters boy friend is And for me to be aware. Bobbie Ask to read the Statement Mr White Objects, As he Jerks it from my hand. I told White I thought Jackie was Lying, As Bobbie gets Irrate, Starts to Cuss And exits via back door. A Minute or so she reenters telling White to Move his g.d. CAR so she can get out the driveway time Around 9:30. As the day goes by Bobbie does not Answer Cell nor does she Return home. 3:30 I see Terry going to Stepdads house 501 Hickory dr I Walked up there to Confront Terry about Statement, he Struck me in the face Several times with A Closed green pocket knife, I reacted After A Couple blows Jerry fell to the floor Rosavelt Kimble ran me off Blood is Blood Water is only H<sub>2</sub>O Reguard less. I Returned to 44. Between 10:30 And 11:00 pm Betty Kimble (my mom) Called, it woke me up she said Terry was going for A Warrant, Where's Bobbie? After looking in Living Room And drive I told her she's Not Here, Hadn't Saw her since Morning we talked for A few minutes I returned to bed.

I enter A Spartanburg County black and white patrol vehicle driven by deputy Rereria. Im taking to the Detention Center, California Ave. Spartanburg, process And placed in whats called the pit No Rights And Unknown why I was arrested. I thought Terry Kumble. 11:30 ARE SO A baloney sandwich, Cup of Water. Around 11:45 taken before Judge Ashmore, After a few minutes the WARRANT is found CRIMINAL Domestic Violence Against Bobbie Ann BRIT. Confused And Shocked! White was there when she left, She had Not Returned home, WAS Not Seen by me Since morning! No one Cared \$10,000.00 bond Jailed pod 3 bed 4, Shoes too small I still Carry A SCARE today. Complain go to lock down (3 X's) No Money, No phone numbers in my head. Jailed on a Bald Face lie! Why, So many questions.

After getting a piece of paper, and stamped envelope I wrote letter to long time friend Steve Ballenger 500 Hickory Dr. It was answered by Stacy Ballenger (X wife of Steve) I had asked what was going on at my house? Where's Bobbie? Why is they knew. Middle March 2014 After last head count I was release to Steven Ballenger. In the parking lot I'm told a blackman now lived in my house with Bobbie I could not return home, they was nothing I could do about it. But I could stay at Steve's (500 Hickory) just about my house at 411. As we drove past my house, I felt my greatest pain. There in my front door stood a Blackman, Bobbie by his side. For days I saw as the two of them act as school kids in love (Turned out per: Bobbie, his name was ERIC who lived with his parents at 110 hilly hill Duncan, S.C.) started out has her Crack Cocaine dealer who needed a place to cook Crack plus his parents objected to a white woman living in their house. Again I asked Wright for help, was told dont mention her boy friend. Regardless of 911 calls from neighbors of parking and traffic. David Shelly SR 440 Hickory dr. was told to get in house, what when an over there was not his bussiness per Deputy Jimmy Parri's as heard by neighbors.
