Additional Information on the VA MISSION Act:

- Strengthens the VA's ability to provide timely and seamless care to VA patients.
- Provides \$5.2 billion desperately needed to prevent interruption of access to needed care for Veterans.
- Modernizes VA health care by making needed investments and improvements in VA assets, and allowing for the recruitment and retention of additional medical personnel.
- Creates integrated networks of high performing providers to support VA in delivering on its critical mission of caring for Veterans where and when they need it. And, consolidates VA's many community care programs to ease confusion for the veteran, community providers and VA staff, thereby simplifying access to care and enhancing efficiency.
- Corrects the "injustice" of seriously disabled veterans from World War II, the Korean, Vietnam and Gulf Wars by making it possible for them to receive comprehensive caregiver assistance as an alternative to being

institutionalized, just as is now done for post 9/11 Veterans.
