We currently have a Home and Community Based Alternatives to PRTF Waiver demonstration Grant for Children with Serious Emotional Disturbance which includes the option of Youth Peer Support and Caregiver Support. The Waiver also includes various other community support services such a respite, therapy, and wraparound community support. The PRTF waiver is currently capped at 50 children and 6 counties. We usually have several children on the waiting list. SC Federation of Families assists with the intake process for families.
