I am writing today to appeal for your assistance in restoring Medicaid benefits for John Grubbs (ss no. 248-51-0687) who was nearing the end of cancer treatments (chemotherapy) when Medicaid notified his treating physician Dr. Dill of Aiken, SC that Medicaid would no longer pay for John's treatments. John's last treatment for squamous cell cancer was July 3, 2014, and according to Dr. Dill, he only had a few treatments left before they were to perform a scan to determine the effectiveness of his treatment. Since treatment has been stopped Dr. Dill has filed an appeal to Medicaid and John has been looking elsewhere to find assistance with paying for the few remaining treatments, but has not been successful. As you know, cancer can be successfully treated with chemotherapy, but when treatment is halted before the cancer has been killed it can grow again. John has been without treatment for nearly 1 ½ months which could be sufficient time to allow the cancer to begin to regrow.

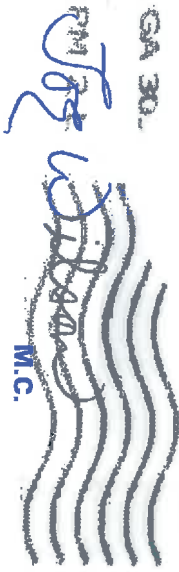

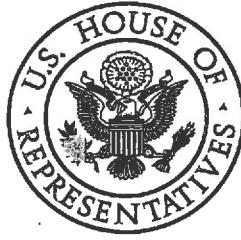
