Okay, we were told by MUSC, the hospital that will be doing the transplant, that my father (Kenneth G. Hopkins) needed to be put on Medicare D. It was around the holidays when we tried to call, we were told to call here and there, we never received any help or any answers. Then in the middle of it all, my father got sick and was out in the hospital. Our next trip to MUSC, it was brought up again about Medicare D. We were told that my father is on the list, but without Medicare D, he will not receive the transplant. Basically they told us they would not give a liver to someone that can not afford to support it. So my father spoke with an attorney that helped get some providers names. We called Human and tried to register him over the internet. The application would not go through, it said to contact Social Security. So, we called Social Security and they told us to call Medicare, we called Medicare and we were told to call Medicaid. Medicaid told my father that he did not qualify, and one of the reasons is because he made too much money. What we try to explain to them is once he receives his transplant his monthly prescription costs will be OVER \$5,000.00!! The reason for this e-mail is basically to beg for help. My father is a very, very loving man. He has two children and three grandchildren that he loves dearly. We have joined a foundation to try to raise money for his transplant and medications, we are currently trying to set up dinners and raffles. Bryan and Jan: Not sure this one needs to be logged at all, it is strictly a Medicare issue and I have spoken at length with the daughter, Ms. Amy Wooline concerning her father and she understands all of her options. I also contacted the Office of Aging and established a direct line of communication with Gloria McDonald in the OofA and she is working with Ms. Woolwine to try and get her father to sign up for Part D. The issue is with Medicare since Mr. Woolwine elected in the past not to participate with Part D. I think the issue has to do with her Dad being confused by his conversations with Medicare, and she now understands what needs to be done and that he is not eligible for Medicaid.

The daughter has my direct number and I asked her to call me with any further problems. She clearly understands her father is some \$600 over the limit for ABD, and does not meet the LOC for NH/HBCS. Glad to get any more data if needed, and Ms. McDonald will walk them through the best Part D provider for the father. Incidentally all of the required drugs needed to maintain the transplant are already covered under Part B service by Medicare. Thanks.


