## Disclosures

18] In November of 2000, while attending Wofford College in Spartanburg, I was arrested for underage possession of alcohol. All subsequent charges were dropped, with no pretrial intervention, fines or community service.

I was asked to drive a friend home, whom was too impaired to drive. While driving his vehicle, I was stopped for speeding. The officers ask to search his vehicle. I agreed and the officers found 5 unopened beer bottles in the rear of the car. We were charged with underage possession of alcohol. I passed the field sobriety tests and a breathalyzer.

All charges were subsequently dropped and I was released.

28] My company Contour Mining & Construction, LLC, was cited for an MSHA (Mine Safety and Health Administration) violation in June of 2014. Our site was inspected by an MSHA inspector, as part of their random, bi-annual inspections. The violation was for a missing mirror on a piece of our heavy equipment. We indicated the mirror was removed due the wooded area we were working in was narrow and the mirror was subject to damage. The violation was issued on the 30 CFR standard 56.14100c. The mirror was replaced on the same day and the citation was vacated on same day (6/24/2014.) The fine totaled \$100.00 to the US Department of Labor.

33] My company, Contour Mining & Construction, LLC, performs contract work for several mines in the state of South Carolina. To my knowledge, none of our current clients have been through proceedings with the mining council.
