Dear Mr. Barbour:

Thank you for writing our agency to express your concerns about Medicaid coverage and eligibility for Mrs. Phyllis P. Petersen.

When our Darlington County Medicaid Office failed to receive Mrs. Petersen's annual review form we contacted Bethesda Baptist Retirement Community (BBRC) staff and advised them of the situation. As required by policy, we closed her coverage effective February 1, 2007.

At BBRC's request, we sent a new application to Mr. Tony Charron, in Hartsville, along with a memo explaining if the application and required documentation was returned it might be possible to reinstate her coverage. Mr. Charron was sent the materials on April 17, 2007, and asked to return them by May 8, 2007. The forms were not returned and her coverage remains closed. On September 6, 2007, our office received a call from Ms. Darlene Quick of Florence, who said she wanted to help the family and requested we send her an application. We sent the application and have not received a response.

Ms. Emeline Clarkson has been in contact with you to explain how you can submit a Medicaid application on Mrs. Petersen's behalf. It may also be helpful to submit, along with the application, a statement from one of Mrs. Petersen's physicians regarding her condition and her inability to apply for herself. We realize this has been a difficult situation and our agency will render a decision as quickly as possible. We will notify your facility in writing once a decision has been made. Please call Ms. Clarkson at (843) 398-4420 if you have any questions regarding this process.

Thank you for your concern for Mrs. Petersen and for all you do to improve the health and quality of life for many of our state's citizens. We regret any hardship your facility may be facing while our agency reaches a decision regarding Mrs. Petersen's Medicaid eligibility.

Medicaid resident Phyllis Petersen is within our care at Bethea Baptist Healthcare in Darlington, SC. Her old Power of Attorney was Tony Charron and he was removed as POA in late 2006. When her eligibility application came up for renewal the family did not contact DHHS in Darlington, SC.

I sent a certified letter in April 2007 to Tony Charron to contact DHHS. I then talked to him back in June 2007 and he gave me the name of the current Power of Attorney, Susan Petersen. Her phone number has been disconnected and Phyllis Petersen's husband Paul, has had his phone disconnected also. I have left repeated phone messages and Paul Petersen's number and have never received any response.

On September 6, 2007, Brandy Johnson our social worker contacted Paul Petersen and he said that the daughter (Susan) would fill out the paperwork so that Phyllis could regain Medicaid eligibility.

We have continued to care for Mrs. Petersen without payment since February 2007. We do continue to bank draft for the recurring income amount. Please help us resolve this situation as soon as possible.

Mrs. Petersen's case was reviewed last on 9/30/2005. We never received a Review Form for 2006. I contacted the social worker at Betha, Betsy Eaddy, who explained that the spouse was in very poor health, and their daughter was not mentally capable of doing a Review Form. The nursing home had no authority to do the Review Form and could not have provided the financial documentation necessary. The case was closed effective 02/01/2007 for failure to return the Review Form. Ms. Eaddy requested I send a new application to a new Authorized Representative, Tony Charon, in Hartsville, which I did along with a memo explaining that if the application forms and required documentation was returned ASAP, it might be possible to reopen her coverage effective the date it had been closed. These forms were sent 04/17/2007 with the requested return date on the DHHS Form 1233 being 05/08/2007. The forms were not returned. The case remained closed. On 09/06/2007 I received a call from a Darlene Quick of Florence, who stated she wanted to help the family and requested I send her an application. This I did on that same day with the requested return date on the DHHS Form 1233 being 09/27/2007. I have not received anything back from this mailing either. Mrs. Petersen qualified for MAONH coverage 02/01/2002 until 02/01/2007. I have no doubt that she would still qualify, but without the Review Forms or applications and documentation being provided, policy dictated that the case be closed and remain closed at this time. I have no record of a Susan Petersen on file. I don't know what relationship she might be to the client or the client's spouse or if she is infact the daughter, who I had been informed by Ms. Eaddy (the former social worker at the nursing home) would not be capable of acting on the client's behalf. I hope this information is helpful.

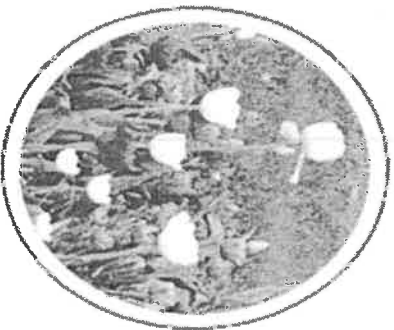

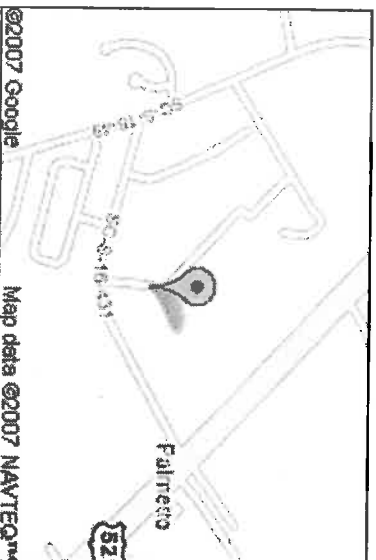
