Subject: Superintendent of Education Bills

2015-2016:

- S. 68, Joint Resolution, Campsen, Grooms, and Davis (Similar to S. 120, H 3041) ---ref. to Jud.
- Deletes Superintendent of Education from list of Constitutional Officers
 - Provides must be appointed by the Governor upon advice and consent of the **Senate. Serves at the pleasure of the Governor.**
 - General Assembly shall provide by law the duties, compensation, and qualifications, the procedures for appointment.
- S. 69, Bill, Campsen, Grooms, and Davis --- ref. to Edu.
- Amends Section 59-3-10, to provide for the appointment of the superintendent of education with advice and consent of the Senate.
 - Four year term, coterminous with Governor.
 - Provides for vacancy.
 - Provides for qualifications:
 - Ⓞ(1) Experience in field of education, including but not limited to, service as classroom teacher, principal, other school or school district administrator, school district superintendent, or any combo.
 - Ⓞ(2) Experience in formation of education policy, including but not limited to, member of school board, or other body at state or local level.
 - Ⓞ(3) Experience in items (1) and (2) and a post grad degree in Education or related subject; **OR**
 - Ⓞ(4) Ten years' experience as practicing attorney.
 - Keeps the bond.
 - Repeals Section 59-3-20 relating to vacancy of office.
- S. 120, Joint Resolution, Bright and Grooms (Similar to S. 68, H. 3041) --- ref. to Jud.
- Deletes Superintendent of Education from list of Constitutional Officers
 - Provides must be appointed by the Governor upon advice and consent of the **General Assembly.**
 - Coterminous with Governor
 - General Assembly shall provide by law the duties, compensation, and qualifications, the procedures for appointment and removal.
- H. 3041, Joint Resolution, Delleney (Similar to S. 68, S.120) --- recommitted to Jud. 3/26/2015
- Deletes Superintendent of Education from list of Constitutional Officers
 - Appointment by the Governor upon advice and consent of the **Senate.**
 - Coterminous with Governor
 - General Assembly shall provide by law the duties, compensation and qualifications, the procedures for appointment and removal.
