RE: Revised Termination Date for State Medicaid and Children's Health Insurance Programs – Proprietary and Confidential – Not Subject to Release Under Freedom of Information Laws

Dear Mr. Keck:

On January 31, 2013, Colgate Oral Pharmaceuticals, a subsidiary of Colgate-Palmolive Company ("Colgate"), notified you that it terminated its National Medicaid Drug Rebate Agreement ("MRA") with the U.S. Secretary of Health and Human Services, effective April 1, 2013. Colgate would like to inform you that it recently amended its MRA termination date to July 1, 2013. Accordingly, Colgate will voluntarily terminate its participation in South Carolina's Medicaid Program, including a Supplemental Rebate Agreement, if any, and Children's Health Insurance Program ("CHIP"), effective July 1, 2013.

In accordance with this revised Medicaid termination date, Colgate understands that, effective July 1, 2013, Colgate products with the following labeler codes will no longer be eligible for reimbursement, whether directly or indirectly, under the State Medicaid and CHIP Programs: 00126, 35000, 42555, 51442, and 65954.
