In addition to the new South Carolina facility, Impresa operates a 100,000 square foot Gardena, California plant, and a 40,000 square foot plant in Wichita, Kansas—employing a staff of over 300. Impresa provides a comprehensive array of engineering, manufacturing and assembly services, and is a trusted supplier to OEMs, Tier 1 and Tier 2 customers in the aerospace industry. The company has a reputation for high-quality, competitively-priced precision sheet metal parts, CNC-machined components and assemblies. Impresa has developed relationships with major national and international corporations in aerospace as well as other industries that require similar service and precision. including 5 and 7-axis multitasking technologies

Impresa's multi-million dollar South Carolina investment will include facility upgrades, and the hiring and training of approximately 100 skilled technicians, administrative and management personnel in the coming years.
