The plan is to meet at the new location at 10:30 a.m. for the groundbreaking and of course the photos of everyone digging up his or her shovel full of dirt. We will then adjourn to the current Pine Ridge Senior Center to unveil the building design and floor plan and to have lasagna, socializing, etc.

The groundbreaking is at the corner of Pine Ridge Drive and Courtney. There will be a red bow on the street sign on the corner. Shortly after you turn on to Courtney, the "driveway" is on the left. We will be parking cars at the Pine Ridge Drive end of the lot. The easiest way to get there is to take I-26 to exit 115 which is for route 321. Get on 321 towards Swansea and Gaston. Shortly after going by the Pilot/Wendy's truck stop and the shopping center, turn right onto Fish Hatchery Road. There is a light at that intersection. Take Fish Hatchery to Pine Ridge Drive. Turn right onto Pine Ridge Drive and then right again when you get to Courtney.

From the groundbreaking to the Senior Center: go back out to Pine Ridge Drive, turn left. At Fish Hatchery Road turn left. At the first light (for Town Hall & the Senior Center) turn right and park. The senior center entrance is on the front of the building.
