The Department requests Commission's approval to enter into an agreement with the City of Travelers Rest to let a contract for the construction of a frontage road from S-563 (Roe Road) to S-22 (State Park Road). Design services required for the preparation of plans and the procurement of right of way will be the responsibility of the City and the Developer.

It is hereby requested that \$20,000 of State Primary Urban Funds be authorized as Preliminary Engineering for the Department's staff to review and coordinate the development of the project.

Agreement with the University of South Carolina to conduct
Experimental Project No. 1 entitled "Ground Modification Systems."

The Department intends to enter into an agreement with the University of South Carolina to conduct an experimental project that will monitor and evaluate the behavior and efficiency of shallow spread footings supporting highway structures. To increase the level of confidence in the use of spread footings, monitoring and collection of spread footing performance data will provide information for refining and improving existing settlement prediction techniques and provide additional documentation on the reliability of spread footings.

The project is scheduled to be completed in twenty-four (24) months at a cost of \$28,363. The FHWA will reimburse the Department 100% of all costs at the completion of the project.

Replacement of Jenkins Bridge Road (County Road)
Over Reedy River, Greenville County

The Department proposes to enter into an Agreement with Greenville County for the purpose of replacing a substandard bridge owned and maintained by the County. The estimated cost for the project is \$410,000. Under the terms of the Agreement, the County would pay 20% of all costs connected with the project with the remaining 80% coming from Federal Bridge Replacement (Off-System) Funds allocated to the Department.

Therefore, Commission's approval is requested to enter into this Agreement with Greenville County.

SUPPLEMENTAL AGREEMENT NO. 11
FIGG & MULLER ENGINEERS

Supplemental Agreement No. 11 to the Consultant Agreement dated June 25, 1982 between the Department and Figg & Muller Engineers be approved. The effect of this supplement is to extend the Construction management services on the I-526 Wando River bridge project in Berkeley and Charleston Counties through February, 1989 if necessary. The amount of the extension would not exceed \$394,558.22.

Construction management services for this project were originally procured through Supplemental Agreement No. 3 and No. 9 with a combined contract limit of \$3,002,307.87. This limit has now been reached. The limit was established from an estimate based on the 30 month construction schedule which was subsequently extended 12 months. Due to the size and complexity of the project and the fact that the contractor will not complete the project until early 1989 an extension is required. The revised limit for construction management services will be \$3,396,866.09. This work is funded under the Interstate Construction Program.
