Thank you for your letter dated January 22, 2009, regarding dental services for Amanda Evans.

Dental benefits for Medicaid beneficiaries over 21 are limited to extractions when done to relieve pain and/or infection, repair work done as a result of trauma, or multiple extractions as needed related to a catastrophic illness. Denture placement is not a covered service for any beneficiary over 21 for any reason. We regret that we are unable to approve your request on behalf of Ms. Evans.
