Greenville News: Leaders hail Mitsubishi expansion as economic win

Mitsubishi Polyester Film Inc., which has produced an array of specialty films in Greer since 1964, is investing \$100 million in the expansion of its facility of nearly a million square feet over 193 acres on Hood Road, where it employs 500 fulltime and 100 contract workers. State, county and local political leaders score it an economic win.

Note: "Mitsubishi Polyester Film has been operating in South Carolina for more than five decades, and their continued commitment to our state is something we are extremely proud of," said Gov. Nikki Haley. "This \$100 million investment to upgrade their existing facility is a tremendous win for Greenville County and for the state of South Carolina as a whole."

Mitsubishi Polyester Film Inc., a supplier of polyester film, is expanding production at its 193-acre site in Greenville County. The company is investing \$100 million in the equipment upgrade at its almost 1 million-square-foot Greer facility, the largest polyester film plant in the United States. The American affiliate of Japan-based Mitsubishi Plastics Inc. opened the then-95,000-square-foot plant in 1964.

South Carolina health officials have halted a suspension order against a Planned Parenthood abortion clinic after the organization requested a review of some of the violations alleged by state inspectors Sept. 11.

Note: The inspections were ordered by Gov. Nikki Haley in August, following the public release of videos secretly recorded by abortion opponents showing Planned Parenthood officials discussing the transfer of fetal tissue to medical researchers.

Note: Haley also said earlier this month that the State Law Enforcement Division had been asked to look at what inspectors found.

Note: "I fully support DHEC's actions, including its referral of the matter to SLED," she said then. "South Carolina is a compassionate state, and we are a state of laws. We will not tolerate law breaking of any kind, particularly as it relates to the callous treatment of human life."

A frustrated House Speaker Jay Lucas has fired off a letter telling the attorney representing rural school districts in a 22-year-old lawsuit to choose between helping a task force find a fix or sticking with a court-ordered deadline. Lucas demanded that the attorney, Carl Epps, choose between fulfilling his "commitment to participate in the task force" or continue to litigate the case through the Supreme Court.

Note: Gov. Nikki Haley, Lucas and other legislative leaders denounced the ruling and asked the court to reconsider its decision, but the justices refused.
