Pursuant to FOIA, I am requesting copies of your agency's contract with Vocational Rehabilitation to perform Medicaid eligibility determinations. It is my understanding that these determinations are performed through their Disability Determination Services Office. If this is not correct, please so advise. Also, please advise if you have a separate contract with DDSN to perform disability determinations for those people who have mental retardation, related disabilities and head/spinal cord injuries. If so, please provide me with a copy of that contract too. I have the MR/RD and HASCI waiver contracts, but if you have a contract specifically delegating DDSN to perform Medicaid eligibility determinations, I would like to obtain a copy of that contract.

It is my understanding that the federal government reimburses a portion of these costs. Is there a separate contract or agreement HHS has with the federal government to perform these evaluations? If any of these documents are available electronically, you could just e mail the link. Please give me a call if you have any questions or need clarification about my request.
