M I N U T E S

A regular meeting of the Anderson County Council was held on October 1, 1991 at 4:30 p.m. in the Anderson County Chambers. Chairman Mike Holden presided.

Chairman Mike Holden called the meeting to order and Mr. Bob Waldrep gave the invocation. Everyone stood and pledged allegiance to the flag.

Mr. Hooper moved to approve the September 3 and September 17, 1991 minutes as mailed. Mr. Holden seconded and vote was unanimous.

Mr. David Standeffer presented third reading of Ordinance #336 amending the Anderson County Land Use and Development Standards Ordinance. He said the amendments were taken directly from the S.C. Code of Laws. A public hearing was conducted and Mr. Carl Johnson spoke. The public hearing was declared closed. Mr. Banister said that he would not support portions of the ordinance which takes rights away from the people. Mr. Waldrep moved to approve on third and final reading and Mr. Holden seconded. Vote was four in favor and one opposed (Banister).

Ms. Cindy Oxford, speaking on behalf of the Junior Assembly, informed Council of a forum on solid waste disposal. The event will be held on October 15, 1991 at 7:00 which is the same time of the next Council meeting. She asked Council to consider changing the time of the Council meeting in order that they may attend the meeting. Council received as information.

Mr. Allgood explained that the City of Pendleton had requested assistance with the purchase of a lawn mower. He moved to approve \$900 from account #445 - Rural Assistance fund to be applied toward the mower purchase. Mr. Holden seconded and vote was unanimous.

Anderson County Council Meeting

Mr. Rusty Burns explained that sometime ago the County had a Community Development Block Grant for loaning money to low to moderate income persons. He said that a loan committee would be helpful in assisting with collecting the money on the grant applications that are delinquent. The following three-man committee was recommended by Mr. Burns: Mr. Jacky Hunter, Mr. Marvin Mattison, and Mr. Larry Kelly. Mr. Holden moved to appoint and Mr. Waldrep seconded. Vote was unanimous.

Mr. Burns said that Council received a letter last week about the Solid Waste Policy Management Act. The committee would be composed of five members appointed by County Council and five members appointed by City Council. He asked for permission that the municipalities be allowed to make their appointments. Mr. Banister moved to allow and Mr. Allgood seconded. Vote was unanimous.

Mr. David Watson presented third and final reading of Ordinance #341 - making provision for tax anticipation borrowing by Anderson County in the aggregate principal amount of not exceeding \$2,825,000 in anticipation of the collection of ad valorem taxes for the fiscal year 1991-1991 at 4.41%. A public hearing was conducted and there were no comments. The public hearing was declared closed. Mr. Holden moved to approve on third reading and Mr. Allgood seconded. Vote was unanimous.

Mr. Watson said that there was a road, Mariner Road off 29 North, which is a minimum maintenance road with about five houses. The County has received numerous requests to upgrade the road. Mr. McClure said it would be more economical to tar and gravel than to keep scraping but the county could not get the extra right-of-way. Council discussed. Mr. Allgood said he had roads in his district like this and would like to see the paving done and the development be made into a special tax district to pay for the paving. Mr. Hooper moved to maintain the road as a County road and Mr. Holden seconded. Vote was unanimous.

Mr. Tom Martin requested an executive session to discuss two litigation matters.

Mr. Holden moved that the time of the October 15, 1991 meeting be changed from 7:00 p.m. to 4:30 p.m. Mr. Waldrep seconded and vote was unanimous. This will allow them to attend the meeting on solid waste disposal.

Mr. Holden announced the 40th anniversary celebration at Owens Corning Fiberglas on Saturday, October 19, 1991 from 10 a.m. to 6:00 p.m. All present were invited.

Mr. Holden moved to appropriate \$2,000 for the Westside Band Wagon from account #801 - Recreation. Mr. Waldrep seconded and vote was unanimous.

Council heard from Mr. Carl Johnson, a concerned citizen.

Mr. Holden moved to go into executive session at 5:35 p.m. to discuss two litigation matters and Mr. Waldrep seconded. Vote was unanimous.

Mr. Holden moved to come out of executive session and back into regular session at 7:10 p.m. Mr. Waldrep seconded and vote was unanimous.

Mr. Martin announced that no action was taken during executive session. All matters involved litigation or personnel.

Mr. Holden appointed Mr. Bob Waldrep and Mr. David Hooper to an Audit Committee and appointed Mr. Ed Allgood to the Local Emergency Planning Committee (LEPC).

Mr. Waldrep said that he would be asking for some money for assisting the Head Start Program in Williamston at the next meeting.

There being no further business, Council adjourned at 7:15 p.m.
