Dr. Cleary, I spoke to someone in your office Tues. and he recommended I email you. I have been on Worker's Comp since June of 2007 with a back injury. Epidurals were given to me which has caused Bilateral Avascular Necrosis in my hips. We had a hearing to determine whether or not my hips would be covered. Avery Wilkerson was the commissioner. No decision was made and he ordered that I see more doctors and then have the Dr. deposed. I later found out that Mr. Wilkerson is an Insurance agent by trade. I also found a web page where "The Hartford" who is the defendant in my case is a bronze sponsor of an organization to which he belongs. I do not understand how an insurance agent could be apt to the WC board. I have been waiting on hip replacement now for almost 2 years. I take 90mg morphine(EMBEDA), 20 mg oxycodone, 18 mg of zanaflex and 30 mg Temazepam daily for pain. Dr. Wagner, an IME for the defense has suggested that I walk on crutches for 12-15 yrs. I have been turned down by SSI Disability today makes twice and they based their decision on Dr. Wilkins, my pain management Dr's report. Monday before last they sent me to a Dr. Steinert who said I needed hip replacement right away...It's obvious Lester Horton and the people at Disability Determination did not even see that report. Please help me out here as my wife (Who works at socastec Library) is pregnant and I can barely walk or get around, and I have no idea how I am supposed to pay bills, child support for my teenage son or have any kind of meaningful life. Thanks, Lena - Yes, Log #0495 can be closed. I spoke with Mr. Cantley who had contacted Sen. Cleary about his family's medical and financial situation. (Note: we may also receive contact from Cong. Brown's office; if so, please use the same log #.)

Mr. Cantley's wife is expecting and her income is \$35,000. He receives workers' comp for a back injury sustained in 2007. He understands their income together is over for OCWI and any children's programs. He is at a breaking point regarding car payments and a time share they can't unload. They are now having to live in a trailer with holes in the floor, and he cannot earn a living to help the situation.

Mr. Cantley is upset with SCVRD and the disability denial and wants to know the job qualifications for examiners who make disability decisions. Mr. Cantley said he will never recover. He needs double hip replacement since his bones have died from the epidurals that were administered for his back, and the only way they can do the thoracic back surgery is to remove his ribs.

We have asked our SCVRD contact to request the disability examiner's supervisor call Mr. Cantley to explain why he was denied disability and what the job qualifications are for examiners making disability decisions.

Mr. Cantley is upset that Avery Wilkerson is an insurance agent by trade yet can serve as a commissioner for Workers' Comp. I sensed Mr. Cantley just wanted to vent in that regard so I didn't contact Workers' Comp.
