I was working with a member from Susan Collins team. This member told me there was something fishy about my story of my sister's killer... I did a story in Maine over the phone with a reporter. The islandpacket.com - go to August 18th it made the front page. I've tried getting help about my story but no one wants to help me the minute they look into it I get denied. My mother always told me if he ever gets out he could be charged in civil courts. Because he went to military courts and sometime during his prison term he went to regular prison. My mother has passed and the thing is he was sentenced to thirty years to life yet he gets out after seventeen years. I never received a letter saying he was being released. WHY?? My sister's best friend received a letter... No one made an effort to send me one. I wrote everybody when my mother passed, letting them know. I am angry and frustrated that this man is freed. Anyone I try contacting tells me it's a legal thing ect... I'm so tired of hearing the same answers... My sister can't come back yet this man brutally killed her and gets out and no one can give me an answer... Good behavior that's crap... My sister was brutally killed and left in the ditch... No one will even take time to even look at my sister's story... It's on the television show on A+E they still play to this day and yet this man is still free... I am very frustrated with this... Yet no one wants to help me or hear me it's like I'm Casper... Yeah I'm nobody and I never even voted

before in my life.. So I'm probably not of importance to you... I just can't sit here and do nothing when this man is out in the world free.. No one can even explain to me why i did not receive a letter. I wrote the parole board every year. I even sent a video of the show on A+E... Back then it was VHS i had it on. I'm totally outraged with this... No matter where I'm sent to with my sisters story i get denied... No answers anywhere...

This one person i wrote to in maine while i was there Shelly pentagree sent him a release so he knows i was doing something. Now I'm here in south Carolina and he's in Ga, Sav Ga... Yet everyone turns the other cheek when i tell my story... I don't think it's right this man is free. It Hurts a great deal and I had to break away for a little bit because I have so much on my plate at once... No I'm not anyone of importance and it probably won't mean a whole lot to you... I'm writing anyone who will listen.. The worse that can happen is i get denied and I'm getting use to that... I am going to work on getting the court script now and just do what i can.. I'm just totally outraged this man is free...

I will not stop fighting.  
I do however Thank you so, so much for taking the time to read this...
