Today, our office received the attached resignation letter from Christopher Nisbet who was suspended from the office of Dorchester County Coroner by Executive Order 2015-20 on October 1, 2015 due to being indicted on a count of Misconduct in Office.

Pursuant to Section 17-5-50, a vacancy in the office of corner shall be filled by the Governor's appointment who will serve until the next general election and his successor shall qualify. Further, the chief deputy or second in command of the coroner's office shall act as coroner until the vacancy is filled by the Governor's appointment.

The Governor is in the process of reviewing recommendations and will make an appointment via Executive Order as soon as possible.
