Per a conversation with Chaney, the US Senate is currently considering the Water Resources Development Act (WRDA) of 2016, which contains critical construction authorization for the Charleston Harbor Deepening Project. If all things continue to progress, the Senate could pass the bill next week. I know Governor Haley has been involved in discussions with Senators Graham and Scott, and we're very appreciate of those efforts.
