A new South Carolina law makes it a crime for someone to falsely claim military service to personally profit. The law signed by Gov. Nikki Haley makes the lie a misdemeanor punishable by up to a year in jail and a \$500 fine. Retired Marine Maj. Gen. James Livingston praised lawmakers Tuesday for passing a bill defending true sacrifice.

S.C. lawmakers took a big step Tuesday to allowing voters the chance to decide whether to stop electing the state's adjutant general. The S.C. Senate gave unanimous key approval Tuesday to a bill that would allow voters to change the state constitution to allow the governor to appoint the adjutant general with approval by the Senate.

**Note:** Once the details are ironed out, the bills would head to Gov. Nikki Haley's desk. She supports the bill, her office said. First Gentleman Michael Haley is a captain in the S.C. National Guard, who returned from a year-long deployment to Afghanistan in December.
