Dear Susan,

Thank you for this information. Please verify for me by Friday, April 24<sup>th</sup>, 2015 at 5pm the steps taken by SCDSS to comply with the following components of the law as you have presented it to me:

Provide that the State will, unless exempted from this requirement by the Director, assure that meetings are convened, not less often than quarterly, whereby representatives of local resettlement agencies, local community service agencies, and other agencies that serve refugees meet with representatives of State and local governments to plan and coordinate the appropriate placement of refugees in advance of the refugees' arrival.

Provide direction and training on medical screening forms and other materials as needed to medical screening providers regarding the Refugee Medical Screening Program

Conduct on-site visits to ensure compliance with the terms of the agreement
