January 22, 2004

The regular monthly meeting of the Department of Transportation Commission was held in the Commission Room of the Headquarters Building in Columbia, South Carolina at 10:00 a.m. on January 22, 2004. In compliance with the Freedom of Information Act, the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: On motion of Commissioner Harrell, seconded by Commissioner Mack, the Commission unanimously passed a motion approving the December 17, 2003 Commission Minutes; copies of which had been previously mailed to each member of the Commission.

SECTION 2: On motion of Commissioner Truluck, seconded by Commissioner Hardee, the Commission unanimously passed a motion excusing the absence of Commissioner Stoddard due to illness.

SECTION 3: The Commission unanimously passed a motion approving the sale of surplus right of way property, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the request of the Mass Transit office requesting an increase in funding for Senior Resources of Columbia, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the request of the Department to advertise and select a consulting firm experienced in all phases of hazardous waste lead abatement for fiscal year 2004 bridge painting projects, as shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the request of the Department to advertise, select and negotiate with a consulting engineering firm experienced in all phases of bridge engineering, especially in the area of rehabilitation for work on the Gervais Street Bridge in Richland/Lexington counties, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the request of the Department to select and negotiate with an arborist to provide consulting services for the US Route 21 widening project in Beaufort County, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the request of the Department to advertise and select a consulting firm for the purpose of providing engineering services for evaluating the feasibility of redirecting the current CSX Transportation corridor through downtown Greer to the existing Norfolk Southern corridor, as shown in detail in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the request of the Department to advertise and select a consulting firm for the purpose of providing hydraulic engineering services for the widening of SC 602 in Lexington county, as shown in detail in the Appendix.

SECTION 10: The Commission unanimously passed a motion approving the request of the Department to advertise and select engineering firms to provide construction engineering and construction inspection (CE/CI) services in District 2 on an on call and as needed basis, as shown in detail in the Appendix.

SECTION 11: The Commission unanimously passed a motion approving the request of the Department to advertise and select engineering firms to provide construction engineering and construction inspection (CE/CI) services in District 3 on an on call and as needed basis, as shown in detail in the Appendix.

SECTION 12: The Commission unanimously passed approving the action of the Department in extending existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 13: The Commission unanimously passed a motion approving the action of the Department in removing roads from the State Highway System, as shown in detail in the Appendix.

SECTION 14: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway letting of November 11, 2003, as shown in detail in the Appendix.

SECTION 15: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway letting of December 9, 2003, as shown in detail in the Appendix.

SECTION 16: On behalf of the Invitations and Resolutions Committee, Commissioner Truluck made a motion to approve a concurrent resolution of the General Assembly naming a portion of US 21 and 78 Bypass in Orangeburg County as the "Earl Middleton Highway". Commissioner Harrell seconded the motion and the Commission unanimously approved the resolution.

SECTION 17: Commissioner Mack reported on behalf of the Mass Transit Committee. The committee report, which was in the form of a motion, recommended Commission approval to develop a statewide rail plan to give the department guidance for prioritization of rail improvement throughout the state. The recommendation also authorizes the Department to facilitate the development of high speed, passenger rail, and freight rail services, and coordinate the necessary studies to take advantage of federal dollars where available.

The committee further requested that staff prepare recommendations for the committee's February meeting detailing the timeline for the development of a statewide rail plan.

SECTION 18: Commissioner Harrell reported on behalf of the Legislative Committee and requested the staff prepare a strategic plan of tracking legislative bills pertaining to the Department.

SECTION 19: There being no further business to come before the Commission, the meeting was adjourned at 11:45 a.m.

1. File 5.667 / US 301 / Bamberg County

During construction of improvements on Road S-51, under File 5.334 in Bamberg County, near the Town of Bamberg, the Department acquired right of way for Road S-51, by Dedication from Town of Bamberg dated March 8, 1962.

During negotiations to acquire new right of way needed for the above project, the Department agreed to convey approximately 900 feet of Road S-51 (Railroad Avenue) and its maintenance responsibility to the City of Bamberg in exchange for new right of way needed for the project. Therefore, a Gratis Quitclaim Deed for approximately 1.03 acres of land to the City of Bamberg was executed on November 13, 2003.

2. File 7.615 / SC Route 170 / Beaufort County

During construction of improvements on Road S-259, under File 7.324 in Beaufort County, near the Town of Beaufort, the Department acquired right of way for SC Route 170, by Condemnation from Lea Ward Sutker, Etal dated January 22, 1959.

During negotiations to settle a difficult acquisition case, the Department agreed to convey a small strip of surplus property in exchange for a similar size parcel needed for new right of way for the above project. Therefore, a Gratis Quitclaim Deed for approximately 0.088 of an acre of land to Riverview Properties, LLC was executed on November 19, 2003.

3. File 46.631A / Road S-98 (Gold Hill Road) / York County

The Department acquired Road S-98 (Gold Hill Road), in York County, near the Town Tega Cay, under the Beltline Act. This road was accepted into the Highway System on May 14, 1949.

A request was received from the adjacent property owner asking the Department to convey a small piece of the abandoned Road S-98 (Gold Hill Road). The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.13 of an acre of land to David C. & Sharyn E. Ball was executed on June 30, 2003 in consideration of \$1,000.00.

4. Road S-75 (East McBee Avenue) / Greenville County

During construction of improvements on Road S-75, in Greenville County, near the City of Greenville, the Department acquired right of way through The Beltline Act.

A request was received from the City of Greenville asking the Department to abandon a small portion of East McBee Avenue to the city. The city agreed to take over the maintenance responsibility so the commission approved the abandonment of the subject parcel in June of this year. Therefore, a Gratis Quitclaim Deed for approximately 0.856 of an acre of land to The City of Greenville was executed on November 25, 2003.

5. Richard B. Russell Project / Abbeville County

During construction of the Richard B. Russell Lake in Abbeville County, it became necessary to relocate bridges and roadways on two secondary roads (Road S-64 & Road S-70) and to "raise in place" bridges on one primary route and three additional secondary roads (SC Route 81, Road S-72, Road S-228, & Road S-269). The Department entered into a contract with the United States of America (Corps of Engineers) dated February 13, 1981 under which the Corps was to remove existing facilities and construct replacement facilities. In exchange the Department agreed to convey, or subordinate to the Corps' right to flood all of its right, title, and interest in and to said lands and right of way for the existing facilities. Since that time, the projects are long since completed and accepted into our State Highway System, it has been requested by our Legal Department to convey by Quitclaim Deed to the Corps all of our interest in the abandoned roads that were relocated as well as subordinate its existing easements where the bridges were "raised in place". Once the Quitclaim Deed is executed the Corps of Engineers will deliver an Easement for the replacement facilities as well as the rights of way for the facilities. Quitclaim Deed was executed on December 8, 2003.

RECOMMENDATIONS

Elderly and Persons with Disability Program Funds

Funding increase for Senior Resources of Columbia – Commission originally approved \$20,000 in federal funds. The Mass Transit Office hereby recommend an additional \$16,000 for a total of \$36,000 in federal funds to enable Senior Resources of Columbia purchase a 17-passenger cutaway.

Bridge Painting Inspection Services

The SCDOT Bridge Maintenance Office seeks approval to advertise, select and negotiate with a consulting engineering firm experienced in all phases of hazardous waste lead abatement (containment, removal and disposal) for fiscal year 2004 bridge painting projects. These are required inspection services to assist the SCDOT in complying with all applicable EPA, SCDHEC and OSHA regulations concerning removal and disposal of this hazardous material.

The Department does not have all the resources to perform this type work so the use of a consulting engineering firm is justified.


Recommendations – 1/22/04

Gervais Street Bridge – Richland/Lexington Counties

The SCDOT Bridge Maintenance office seeks approval to advertise, select and negotiate with a consulting engineering firm experienced in all phases of bridge engineering especially in the area of rehabilitation. The existing electrical service for light standards on the Gervais Street Bridge are failing and therefore in need of complete rewiring of the existing service.

The work will consist of selecting and designing plans for the rewiring of electrical service to the existing light standards. Also included in this project will be cosmetic work along with some minor structural rehabilitation.

The Gervais Street Bridge is on the National Register of Historic Places and therefore requires special care in order to maintain its functionality. The Department does not have all the resources to perform this type of work so the use of a consulting engineering firm is justified.



REQUEST FOR ARBORIST CONSULTING SERVICES

The Department requests Commission approval to select and negotiate with an arborist to provide consulting services for the US Route 21 widening project in Beaufort County. With increasing public interest to save the trees along the US 21 corridor, an arborist would work with SCDOT engineers to minimize and avoid tree impacts, where possible.

Funding for this service would be provided by the project budget through the Low Country Council of Governments Bonding Agreement.

**REQUEST FOR PROFESSIONAL ENGINEERING SERVICES FOR GREER
RAILROAD RELOCATION FEASIBILITY STUDY IN GREENVILLE AND
SPARTANBURG COUNTY**

The Department requests Commission approval to advertise and select a consulting firm or firms for the purpose of providing engineering services for evaluating the feasibility of redirecting the current CSX Transportation corridor through downtown Greer, SC to the existing Norfolk Southern corridor. The redirection of train traffic and removal of the CSX Transportation track will improve safety and efficiency of highway and railway traffic by eliminating at-grade crossings and allow for the continued development of the 1999 "Our Town" master plan for Greer. The Department is working with the City of Greer in the development of this project.

Funding for engineering of this project in the amount of \$250,000 has been obtained through the Transportation and Community and System Preservation Money of the 2003 Congressional Earmark Program (STIP page 118).

**REQUEST FOR PROFESSIONAL HYDRAULIC ENGINEERING
SERVICES FOR THE WIDENING OF SC 602 FROM EMMANUEL
CHURCH ROAD TO APPROXIMATELY ONE MILE BEYOND SC 6
IN LEXINGTON COUNTY**

The Department requests Commission approval to advertise and select a consultant firm for the purpose of providing hydraulic engineering services for the widening of SC 602 in Lexington County. Based on the current and proposed workload of the Hydraulic Engineering Section, the Section does not have sufficient staff to conduct the necessary studies. The project will be funded with funds from the Surface Transportation Program.

Recommendations – January 2004

Request for Professional Engineering Services

The Department requests Commission approval to advertise and select engineering firms to provide construction engineering and construction inspection (CE/CI) services in District 2 on an "on-call" and "as needed" basis. Contracts will be for a period of three years. Services will be performed on those projects, which the Department does not have adequate staff and/or expertise to perform in-house.

Recommendations – January 2004

Request for Professional Engineering Services

The Department requests Commission approval to advertise and select engineering firms to provide construction engineering and construction inspection (CE/CI) services in District 3 on an "on-call" and "as needed" basis. Contracts will be for a period of three years. Services will be performed on those projects, which the Department does not have adequate staff and/or expertise to perform in-house.
