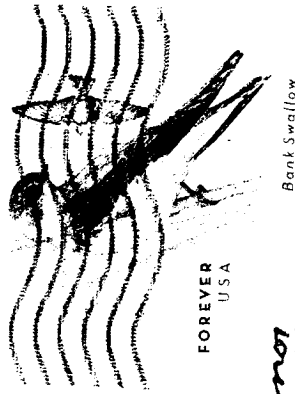

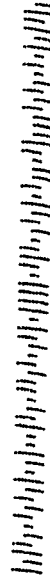

 the Attorney General office in to see if I can get the Attorney General to
 appoint me and Attorney to take my case Allen Wilson, I am Wilson and
 sending you this information legal document for you can give it to
 Governor Mike R. Holcomb, the Statute, which came on the books as § 2 of the
 Ku Klux Klan Act of April 20, 1871. 17 Stat. 13, provides that "Every
 person" who under Color of State Law or Custom "Subjects, or Causes to
 be Subjected, any Citizen to the deprivation of any right,
 privilege or immunity secured by the Constitution and Laws,
 shall be liable to the party injured in an action at Law, Suit in
 equity, or other proper proceeding for redress to wit: "Every
 person except Judges. Despite the plain import of those words, the
 Court decided in Tenney v. Bradshaw, 341 U.S. 367, 71 S. Ct. 783, 95
 L. Ed. 1019, that State Legislators are immune from suit so long as
 the deprivation of Civil right, which they caused a person occurred
 while the Legislators traditionally have power to act; 71 S. Ct.
 at 789. I dissent from the creation of that Judicial Exception and do
 from the creation of the present one. The Congressional purpose seems to
 me to be clear a condition of lawlessness existed in certain of the States
 under which people were being denied their Civil Rights. Congress
 intended to provide a Remedy for the wrongs being perpetrated. And
 members of the Judiciary were implicated in the state of affairs, which
 the Statute was intended to rectify. It was often noted that
 [I]mmunity is given to Crime, and the record of the public

Tribunal, are searched in vain for any evidence of effective action
Cong. Globe. 42d Cong-1st Sess. 374. Mr. Rainey, South Carolina
noted that [T]he Court, are in many instances, under the control of
those who are wholly inimical to the impotent administration of
