Good Afternoon TAC Members,

Earlier today the Medicaid Transportation Advisory Committee held its quarterly meeting. As you would suspect, several questions/concerns/observations arose regarding the current request for proposal. Because of requirements set forth in our state's procurement law, DHHS staff could not respond to questions, etc. because we are in the midst of the quiet period – that time between the final deadline for submission of questions and the opening for proposals which begins October 15th. However, the TAC members felt it important we provide input and recommendations. This is consistent with our role as defined under Act 172 which established TAC.

We agreed that I will collect comments, questions and recommendations from you and submit that information as a packet from TAC to DHHS. We need input from all committee members. If you have any items related to the RFP you would like brought to the attention of DHHS, please provide that to me by close of business on Tuesday, September 30th. I will then submit everything to DHHS on behalf of TAC.
