Here's the proposed text – much of the “whereas” text is lifted directly out of the ABF joint resolutions that have been floating around for the past 18 months or so. This Executive Order would basically preempt the JR and put us straight to work on trying to develop a more specific funding model (and a more specific regulatory relief plan).

I'll be off the grid next week (the 3<sup>rd</sup> week in July is the only one where I ever seem to be able to escape), so feel free to respond to me if you like...just know I won't be able to get back to you for a few days. Ted and Veldran are going to take the temperature of the other presidents and the committee chairs, so it's also fine to discuss it with them next week, if you want to.

If we get good buy-in for this approach, we'd probably release the EO in about two weeks. Thanks.
