**Associated Press:** Haley signs bill funding billions for roads by borrowing

Gov. Nikki Haley reluctantly signed legislation Wednesday that will let the state borrow \$2.2 billion to jump-start improvements to South Carolina's deteriorating roads, saying she did so only because its so-called reforms are better than nothing. The Republican governor said the law provides a step forward in highway funding and marginal improvements to the Department of Transportation's governance. "To claim this law as anything close to a victory, to represent it in any way as a true solution to our infrastructure problems" would be deceiving the public, she said in a letter to legislative leaders she sent along with the signed law.

Gov. Nikki Haley signed a \$4 billion road and bridge spending plan Thursday that includes repairing Malfunction Junction in Richland and Lexington counties. The proposal also includes replacing nearly 400 bridges and giving the governor more control of the state Transportation Department. Still, Haley expressed disappointment in the proposed changes for restructuring the Transportation Department commission. "So let us all be honest about what we accomplished in this bill: incremental and incomplete reform, or put a different way, far less than the people of South Carolina both expect and deserve from us," she wrote in a letter to lawmakers.

Gov. Nikki Haley approved billions of dollars for road and bridge projects across the state Wednesday even though she said reform measures in the bill that took lawmakers years to pass don't go far enough. "I have done so for one reason and on reason only—it is a better option than what we will have without this bill: a full reversion to the even more unaccountable and defective system that was replaced in 2007," Haley said in a rare signing statement. "This bill does move South Carolina marginally forward by replacing General Assembly selection of the Transportation Commissioners with gubernatorial appointment," Haley wrote. "But let's be clear that 'progress' is little more than window dressing. The process for confirmation and removal of commissioners is deeply flawed."

Governor Nikki Haley signed S.1258 with little fanfare Wednesday. The governor sent a letter to Senate President Pro Tempore Hugh Leatherman Wednesday announcing her signature of the bill. Haley stated in her letter she believes the bill "accomplished incremental and incomplete reform, or put a different way, far less than the people of South Carolina both expect and deserve from us." The governor noted that South Carolina is moving forward by giving her office appointment authority over the Transportation Commission: "...but let's be clear: that "progress" is little more than window dressing. A legislative delegation can kill any nomination without a reason, without a hearing and without a vote. The governor can hire a commissioner but he or she does not have the ability to fire one - not without asking for permission first."

Governor Nikki Haley signed the roads bill into law Wednesday, but with strong disapproval for the reform aspect of the bill. Gov. Nikki Haley is ceremoniously signing a law that bans most abortions in South Carolina at 20 weeks beyond fertilization. Supporters are celebrating the law Wednesday at a Christian school in Greenville County that caters to children with disabilities. The law took effect with the governor's signature two weeks ago. The ban's only exceptions are if mother's life is in jeopardy or a doctor determines the fetus cannot survive outside the womb. Its definition of "fetal anomaly" makes it illegal to abort a fetus with a severe disability if the child could live. Such anomalies are generally detected around 20 weeks.

Gov. Nikki Haley traveled to a Christian school for children with disabilities to re-sign a new state law that bans abortions at 20 weeks of pregnancy, holding the ceremony in the heart of the conservative Upstate. Haley said she did not bring this second and more symbolic bill-signing to the Greenville area because abortion is so political. Instead, she said, it's because she's a mom. "I'm not pro-life because the Republican Party tells me," Haley said. "I'm pro-life because all of us have had experiences of what it means to have one of these special little ones in our life."

Gov. Nikki Haley held a ceremonial signing ceremony for a recently-passed law that would ban abortions at 20 weeks, which bill sponsor Rep. Wendy Nanney said was just the first step in the effort

to chip away and eventually overturn abortion rights in South Carolina. "We are at 20 weeks and we're going to keep pushing," Nanney said at the ceremony held at Hidden Treasure Christian School, a religious school for children with intellectual and physical disabilities. The law bans all abortions at 20 weeks or later and makes no exceptions for rape or incest. The only case in which an abortion can occur past 19 weeks in South Carolina is when the fetus will die or the health of the mother is threatened. Doctors who violate this law could be jailed.

Abortions after 19 weeks are now illegal in the Palmetto state. Surrounded by kids from Hidden Treasure Christian School in Taylors, Governor Nikki Haley's signature made it official, Wednesday. The 4 year fight to get to this point is a rocky one; so much so, Governor Haley addressed the controversy in front of the crowd. "There's been controversy around this bill and they always are with pro-life bills. I want us to respect the controversy, but I also want us to see a responsibility with that," she said. The bill – which asserts a fetus can feel at 20 weeks – calls on medical research that some critics say isn't entirely truthful. "We go with a responsibility to not judge those that are contemplating abortion or choosing abortion, but to see it as our responsibility to tell them those stories," said Haley.

Gov. Nikki Haley will be at the Hidden Treasure Christian School in Taylors on Wednesday to celebrate the signing of the Pain-Capable Unborn Child Protection Act into law. The law bans abortions after 19 weeks and was authored by State Representative Wendy Nanney of Greenville. According to the legislation, after twenty weeks, an unborn child "reacts to stimuli that would be recognized as painful if applied to an adult human, for example, by recoiling." Haley signed the bill into law on May 25.

South Carolina State University is officially free of \$12 million in state loans, but it must repay a separate, \$6 million loan over the next 16 years. Gov. Nikki Haley signed the terms into law Tuesday without fanfare. The law forgives \$8 million next year, then \$2 million each in the following two years, provided SC State's finances keep improving. The university must make yearly payments of \$355,000 on the other loan. State officials approved both loans in 2014.

"It has been obvious since very early in this presidential campaign that Donald Trump is a racist, a bigot, a xenophobe, and a misogynist who plays footsie with the world's worst regimes and advocates committing war crimes," Harrison said in a press conference at the party's Columbia headquarters. Harrison noted some elected S.C. officials publicly have objected to Trump's comments and called on them to withdraw their support for the presumptive GOP presidential nominee.

"When I was thinking about running, I was telling people, I identify as a transgender. But I am deathly afraid of my political success being ruined here in South Carolina and not being able to do anything else because of the negativity that comes with it," she said. "I went through some counseling and decided to go for it."

South Carolina's top Democrat is calling on elected Republicans to rescind their endorsements of Donald Trump, saying Wednesday that the presumptive GOP nominee is a racist and xenophobe, in part due to his race-based attacks on a Hispanic judge. During a news conference, party Chairman Jaime Harrison said that, while he respects Republicans and their party, he doesn't understand how officials including Gov. Nikki Haley can condemn Trump's divisive rhetoric, yet say they still feel he's the best choice to be president. "To say these types of remarks, and then constantly defend them, is disqualifying for a presidential candidate, period," Harrison said, adding that a President Trump would put the country "in peril."

State Ethics Commission filings show Leatherman had \$1.2 million on hand as of late May after spending \$400,000 in the past two months, mainly on television advertising. The disclosure shows the 35-year Senate veteran's campaign is concentrating on his main challenger, former Florence County GOP Chairman Richard Skipper, ahead of Tuesday's GOP primary. After a strong fundraising pace earlier this year Leatherman saw increased support from Charleston-area donors who collectively gave more than \$35,000 — the most coming from any region in the state during the April and May reporting period.

After a rough and tumble couple of years as Richland County sheriff, Leon Lott is seeking a sixth term, facing a challenger for the first time in eight years. Lott has twice tangled publicly with the governor, been the focus of criticism for investigating his own deputies and withstood the glare of the

national spotlight when one of his officers was filmed manhandling a disruptive high school student. At the same time, the homicide rate has been climbing, and gun and gang violence, escalating – all as scrutiny of police mounts. Former State Law Enforcement Division agent James Flowers is angling to knock Lott out Tuesday of the office Lott has held for 20 years – and from the state's largest sheriff's department, where Lott has worked for 41 years.

Richland County Sheriff Leon Lott will face a challenger in next year's primary election for the first time since 2008. James Flowers, a former South Carolina Law Enforcement Division senior special agent who was once a Gamecock defensive lineman, announced Wednesday he will run as a Democrat in 2016. "I am running as a candidate that will bring law enforcement and the community together and make Richland County a safer place for everyone," Flowers said. "People want safer streets, schools and neighborhoods, and they expect law enforcement officers to provide that safe environment. I understand that expectation, and I want to be a transformative leader for Richland County and the sheriff's department." Meanwhile, Lott will seek a sixth term in office.

**Associated Press:** FBI offers reward in '09 case of NY girl likely killed in SC

Seven years after a teen from upstate New York disappeared while on a spring break trip to Myrtle Beach, the case is now considered a homicide and a \$25,000 reward is being offered for information leading to a conviction, the FBI said Wednesday. Brittanee Drexel of Rochester, New York, was 17

when she was last seen leaving a beachfront hotel in April 2009 in video recorded on a surveillance camera. The investigation indicates Drexel was likely held against her will and killed in the vicinity of McClellanville, a fishing hamlet about 60 miles southwest of Myrtle Beach, said FBI South Carolina Special Agent in Charge David Thomas. Drexel's cellphone transmitted its last known signal the day after she disappeared near the South Santee River, about 15 miles outside McClellanville.

For seven years since Brittanee Drexel vanished, the teenager's loved ones held on to a slim hope that she was still alive, somewhere. After hearing from the FBI this week, that hope slipped away. The authorities think the 17-year-old New York girl, who came to Myrtle Beach for spring break in 2009, was taken and held captive in McClellanville for days until she was slain. Her parents and investigators on Wednesday gathered in the Charleston County town and appealed to the public for the final pieces they need to solve the mystery altogether and bring Drexel's killers to justice and her remains home to her family.

Brittanee Drexel, a New York teen missing since 2009, spent several days here in 2009, was held against her will and then killed, the FBI announced today. No body has been found and no arrests have been made, David Thomas, special agent in charge of the FBI in South Carolina, said at a press conference outside a magistrate's office. "What we've come to discover through the course of this investigation is that Brittanee Drexel did leave the Myrtle Beach area, we believe she traveled to this area around McClellanville and we believe she was killed after that," he said. The FBI is offering a reward of \$25,000 for information leading to the arrest and conviction of whomever is responsible, he said.

Investigators revealed Wednesday that the case of a teen, who went missing while on vacation in Myrtle Beach seven years ago, is now being investigated as a murder. "After seven long years of waiting and praying for the return of my daughter we know that she isn't coming home alive," said Dawn Drexel, mother of Brittanee Drexel, who was 17 and on vacation in Myrtle Beach with friends when she was reported missing in April 2009. David Thomas, a special agent in charge with the Federal Bureau of Investigation, said that officials believe Brittanee Drexel was held against her will in the McClellanville area for several days before she was killed. Officers would not say whether the remains of Drexel were ever found or exactly why they believe she is no longer alive.

After a federal court moved up Dylann Roof's trial date this week, 9th Circuit Solicitor Scarlett Wilson indicates she will prosecute former North Charleston police officer Michael Slager later this year. Wilson's filing in state court sets up the possibility of two potentially historic trials unfolding at the same time this fall in downtown Charleston. Slager is charged with murder in the April 2015 shooting death of Walter Scott. He was set to be tried Oct. 31, but Wilson asked a judge to reschedule the proceeding to avoid a scheduling conflict with her case against Roof, the accused killer of nine people at Emanuel AME Church. A judge on Tuesday set Roof's trial in federal court earlier than the state's Jan. 17 date, likely eliminating the chances of the state trial happening as planned.

Two F-16 fighter pilots who survived a midair collision in Georgia are home with their families, the commander of the South Carolina National Guard said Wednesday. Pieces of wreckage from both jets were found in remote, wooded areas about 2 miles apart from each other, Guard officials said. The two aircraft collided over a bombing range in Jefferson County, Georgia, about 9:15 p.m. Tuesday.

"The case has been settled as to all parties," said Mike Gruenloh, who represented Citadel cadet Zachary Rutherford in his suit against the school. Rutherford was a freshman at the time of the alleged attack in the fall of 2013. First-year cadets live regimented lives under the public military college's long-standing fourth-class system and must obey any lawful order from an upperclassman officer. Although hazing is forbidden by school policy, it has been a documented problem at the school for decades, and several cadets have reported in recent years that physical attacks remain rampant in the barracks. The school reported last April that a three-month internal investigation had confirmed 19 cases of hazing.

Speaking in English, Modi used dashes of humor, drawing a parallel between the rough-and-tumble politics of his own nation and the U.S., which he described tongue-in-cheek as "harmonious" and well-known for bipartisanship. Modi, a keen advocate of yoga, also referenced cultural ties, citing estimates that "more Americans bend for yoga than to throw a curve ball."

Two Palestinians opened fire near a popular open-air market in central Tel Aviv on Wednesday night, killing four Israelis and wounding at least five others in one of the deadliest attacks in an eight-month wave of violence. "Two terrorists opened fire at civilians," Tel Aviv district police commander Moshe Edri said, adding that one of the detained attackers was being treated for a gunfire wound. Police had initially said there might be a third attacker but later ruled that out after extensive searches and examining security camera footage. Tel Aviv's Ichilov Hospital said the four slain Israelis had been brought to the facility in critical condition and later died of their wounds.
