SECTION 1: The Commission unanimously passed a motion approving the Minutes of February 18, 1993 with the following correction to read as follows:

SECTION 2: The Commission unanimously passed a motion approving the monthly reports as published by the Department of activities for the month of February, 1993.

SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00, during the month of February, 1993, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreements No. 11(G), 12(S), and 13 with Stevens & Wilkinson, Inc., to provide additional services for the Weigh-In-Motion Stations in Greenville and Spartanburg Counties at an estimated cost of \$108,315.60, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the City of Columbia for engineering services and construction of enhancement along Gervais Street and Assembly Streets in Columbia at an estimated cost of \$8,320,000.00 of which one-half is included in COATS - FY 93 and one-half in COATS - FY 94, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the City of Columbia for engineering services for the Rail Corridor Revitalization in Columbia at an estimated cost of \$844,000.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the Columbia Metropolitan Airport for engineering services on Airport Road - SC Route 302 to SC Route 602 (Platt Springs Road) in Lexington County at an estimated cost of \$350,000.00, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the City of Myrtle Beach for the design and construction of a signal system on Oak Street (S-196) at an estimated cost of \$20,000.00 and \$120,000.00 respectively, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the City of Spartanburg for the design and construction of the W. O. Ezell Boulevard (US 29) and Union Street (SC 56) signal systems at an estimated cost of \$244,000.00, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion authorizing the Department to supplement an existing agreement for consultant services on the Hilton Head Cross Island Expressway for Supplemental Agreement No. 8 with Kimley Horn, Inc., at an estimated cost \$2,386,189.00, as shown in the Appendix.

SECTION 11: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 1 with Wilbur Smith and Associates, Inc., to proceed with the next phase for widening SC Route 101 at an estimated cost of \$378,226.25, as shown in the Appendix.

SECTION 12: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the North Carolina Department of Transportation for the replacement of the Buster Boyd Bridge over Lake Wylie on Route 49 in York County, SC and Mecklenburg County, NC at an estimated cost of \$10,200,000.00 with the Department's share to be approximately \$5,100,000.00, as shown in the Appendix.

SECTION 13: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the City of Greenville for Preliminary Roadway and Bridge Design and Environmental Assessment at an estimated cost of \$689,714.64, as shown in the Appendix.

SECTION 14: The Commission unanimously passed a motion authorizing the Department to comply with the Stormwater and Sediment and Erosion Control Act and to extend existing agreements with the following companies: Howard, Needles, Tammen & Bergendoff Inc., Parsons, DeLeuw, Inc.,/LPA Group, Inc., LPA Group, Inc., CRS Sirrine, Inc., Rust Environment and Infrastructure (BAKK), Piedmont Olsen Hensley, Ralph Whitehead and Associates, Florence and Hutcheson, Inc., Stevens and Wilkinson, Inc., Parsons, Brinckerhoff, Quade and Douglas, Inc., Kimley Horn and Associates, Inc., Wilbur Smith and Associates, Inc., and Sverdrup Corporation at an estimated cost of \$475,000.00, as shown in the Appendix.

SECTION 15: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a quitclaim deed dated February 23, 1993 conveying approximately 0.39 acre of land in Spartanburg County to Silas Shands for the consideration of \$900.00, as shown in the Appendix.

SECTION 16: The Commission unanimously passed a motion revising the June 18, 1992 allocation of State Transportation Assistance Program State General Funds for Public Transportation for FY 92-93, as shown in detail in the Appendix.

SECTION 17: The Commission unanimously passed a motion amending the June 18, 1992 Statewide Allocation of Federal and State Transportation Funds for FY 92-93, as shown in detail in the Appendix.

SECTION 18: The Commission unanimously passed a motion accepting a report by the Department of right of way payments on roads in the State Secondary "C" Construction Program for Bamberg, Beaufort, Chesterfield, Darlington, Jasper and Lexington counties, as shown detail in the Appendix. At the request of Commissioner Harvey, it is noted that the payments made in Beaufort County were for a road that serves a school and intersects with a main highway.

SECTION 19: The Commission unanimously passed a motion approving the sale of surplus used motor vehicles and equipment located at the Department's Equipment Depot, Shop Road, Columbia, South Carolina, bids for which were received on February 24, 1993, as shown in the Appendix.

SECTION 45: On motion of Commissioner Wilder, seconded by Commissioner Harvey, the Commission unanimously passed a motion adopting the following directive concerning news releases:

A copy of this release shall be sent to all the media of the county concerned (press, radio, and TV), with a copy to the Chairman of County Council and to each member of the Legislative Delegation who has a portion of such county within his or her district.

STATEWIDE TRANSPORTATION COORDINATION PLAN

EXISTING SERVICES

- Eighteen (18) active, public fixed route transportation operations and approximately 190 different human service organizations are currently providing or purchasing transportation services for their clients in South Carolina.
- Approximately 1,500 vehicles are operating throughout the State.
- South Carolina's public transit and human service agencies currently provide approximately 18,939,809 passenger trips each year, while the projected demand for services is approximately 24,992,742 annual passenger trips.
- A minimum of just over \$46.2 million Federal, State and local dollars are used annually to support the delivery of public transit and human service transportation in South Carolina.

PRIMARY STUDY FINDINGS

- Approximately 24% of the statewide estimated need for transportation services is currently unmet.
- Existing vehicles (both human service and public transit for which data was available) are basically under-utilized (an average of only 1.7 hrs. per day/vehicle), indicating that additional vehicle capacity is available within the existing fleets.
- South Carolina has five successful examples of transportation coordination: Pee Dee RTA; Santee-Wateree RTA; Greenville Transit Authority; Aiken Area Council on Aging; and, the Barnwell County Council on Aging.
- The consensus among many study participants was that SHIMS funds should be allowed to be used for administrative and operational costs as well as capital costs.
- Many of the organizations that participated in the study indicated that the coordination of transportation services should be mandated by the South Carolina General Assembly.
- State level responsibility and authority for ensuring the coordination of transportation services should be placed with an **existing, neutral agency** having appropriate authority and influence.
- Flexibility in the development and delivery of coordinated transportation services at the local level is essential to the acceptance of the concept and its' successful implementation.

BENEFITS OF TRANSPORTATION SERVICE COORDINATION

- Improves service quality through consistency in service delivery standards.
- Increases the number of passengers that can be carried within the constraints of existing resources.
- Results in short and long-term savings in capital and operating expenses through the elimination of duplicate activities and services.

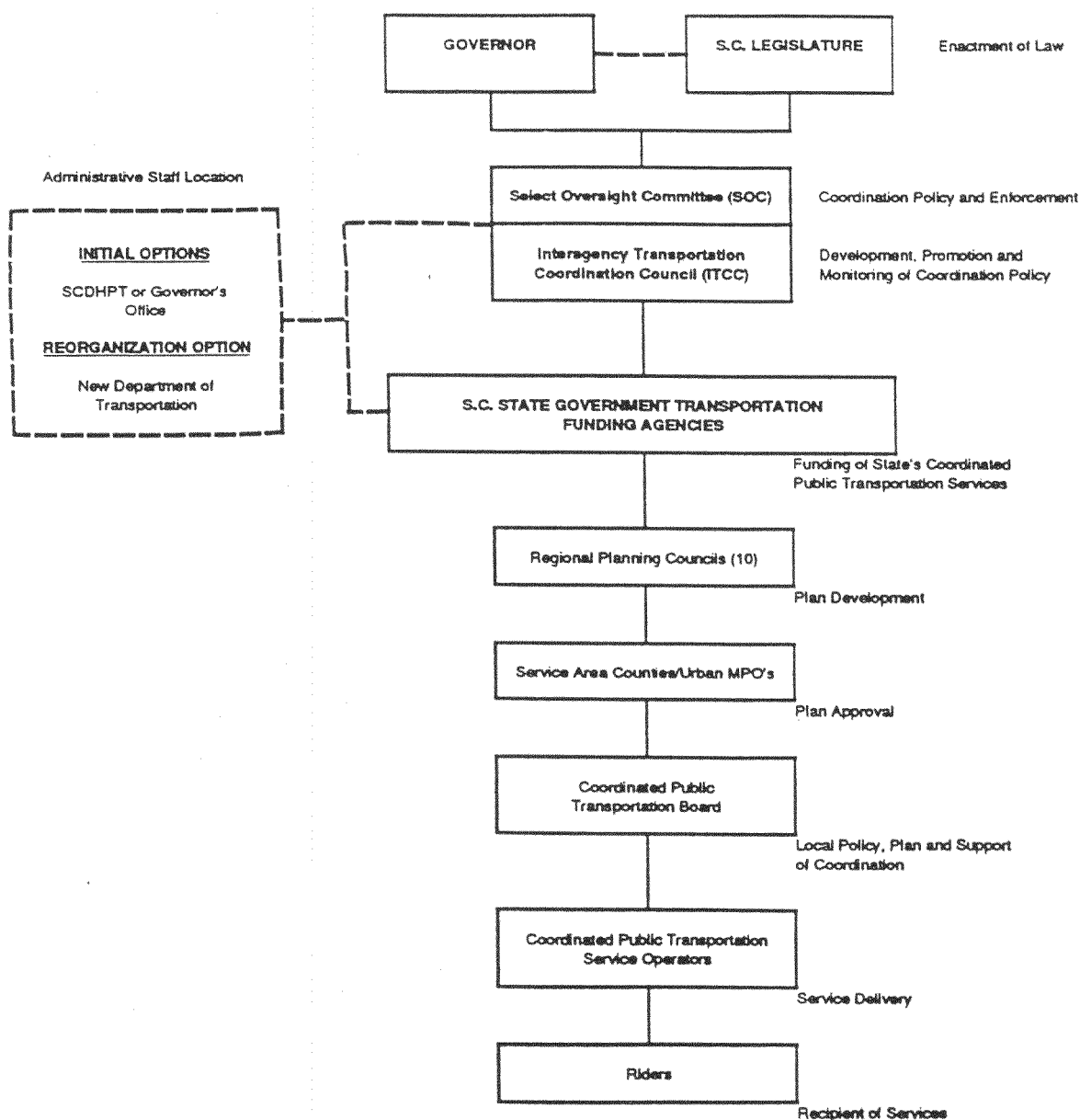
STUDY ADVISORY COMMITTEE POSITIONS AND CONSENSUS

- Effective transportation coordination will not occur under South Carolina's existing laws and program regulations and this fact must be considered in plan development.
- Until and unless State government restructuring occurs, an existing, neutral mechanism with legislative authority to enforce and direct coordination efforts must be designated as the transportation coordination entity in order to begin addressing and resolving Statewide issues and barriers, including, but not limited to:
 1. determination of appropriate service delivery organization(s);
 2. uniform service data reporting;
 3. centralized grant review and certification;
 4. line item budgets and full cost allocation/accounting/billing;
 5. standardized records and reporting;
 6. service and performance evaluation standards;
 7. vehicle specifications;
 8. joint purchasing;
 9. insurance coverage; and
 10. training and technical assistance.

RECOMMENDED STATE TRANSPORTATION COORDINATION PLAN

- As a prerequisite to adopting a plan and implementation strategy, the State, through legislative preamble, must define transportation coordination in South Carolina, and articulate planning goals and objectives which may be utilized for future program evaluation.
- It is recommended that enabling legislation include a provision directing each State board or commission, whose functions involve the administration of programs for the public to issue departmental policies in support of coordinated public transportation and to delineate goals and objectives regarding policy implementation in accordance with the Statewide statutory coordination policy.
- It is recommended that each county in the State be required by statute, with State funding assistance and according to State guidelines, to develop and adopt a Coordinated Public Transportation Service Plan. An individual county plan may be completed as part of a regional plan upon passage of a resolution by the county governing body and the submission of that resolution to the regional planning council.
- It is recommended that the Division of Motor Vehicle Management (DMVM) of the State Budget and Control Board be mandated to ensure the cost efficient utilization of State-owned vehicles in local coordinated public transportation service plans.
- It is recommended that enabling legislation be enacted as an amendment to existing S.C. Department of Education statutes specifically authorizing and empowering any school district to rent or lease any State owned vehicle, during any time when such vehicle is not needed for the transport of school children, to coordinated public transportation service operators as designated in approved and certified local plans.

IMPLEMENTATION STRATEGY

Implementation of the recommended plan will involve a variety of interdependent, equally important actions. These actions are education, legislation, and regulation.

- Education - a comprehensive education campaign defining coordinated public transportation policy, directives, and guidelines will be directed toward four (4) primary audiences:

- State Agency Boards and Commissions
- Local Government Officials
- Regional Planning Councils/MPO's
- Local Service Operators/Purchasers

- Legislation - A statewide coordinated public transportation bill must be enacted and should, at minimum, address the following:

- Repeal Sections 7 through 14 of Act 82 of 1977, relating to the Interagency Council on Public Transportation.
- Amend Section 2 of Act 82 of 1977 redefining the term "Public Transportation." The term "public transportation" shall mean every conveyance of passengers by bus, van, rail or any other ground surface vehicle or service which is provided to the general public on a regular and continuing basis.
- Establish and define a State of South Carolina Public Transportation Coordination Policy consistent with the Statewide Transportation Coordination Plan and legislative intent.
- Establish funding for a Coordinated Public Transportation Assistance Fund and define the purpose of the Fund and its use.
- Amend South Carolina State Code Section 12-27-1300 of Act 197 of 1987, relating to the Select Oversight Committee in order to provide additional duties, responsibilities, and expansion of membership, for implementing the South Carolina Statewide Public Transportation Coordination Policy.
- Provide for the creation of local Coordinated Public Transportation Boards, and define the duties, responsibilities and membership thereof, as well as define "Coordinated Service Operators" in compliance with the State Public Transportation Coordination Policy.
- Provide for and define additional duties and responsibilities of Regional Planning Councils/Metropolitan Planning Organizations relating to the Statewide Public Transportation Coordination Policy.
- S.C. Education Law should be amended to specifically authorize and empower all school districts to rent or lease any state owned vehicle, during any time when such vehicle is not needed for the transport of school children, to coordinated public transportation service operators as designated in approved and certified local plans.

Further, school districts should be authorized to engage in contracts to provide coordinated public transportation service as part of the local service plan.

- Public Service Commission Statute could be amended to allow a portion of the Motor Transport Fund and Interstate Motor Carrier Registration Fee to be earmarked for appropriation to the proposed Coordinated Public Transportation Assistance Fund.
- State Budget and Control Board statutes should be amended to:
 - Allow the purchase of insurance coverage through the Insurance Reserve Fund by small chartered, nonprofit eleemosynary agencies/organizations engaged in the provision of either general public transportation or specialized transportation.
 - Allow flexibility in the acquisition of liability coverage, rather than requiring that if one type of insurance coverage is purchased through the Insurance Reserve Fund, then all liability exposure coverage must be insured with the Budget and Control Board.
 - Allow the Insurance Reserve Fund to offer additional types of coverage, such as worker's compensation, employee bonding, vehicle vandalism, etc.

IMPLEMENTATION COSTS

- The first year costs related to implementing the recommended plan would be approximately \$845,990. In subsequent years, the costs would be reduced to approximately \$445,990. since the demonstration project funds would eventually be eliminated and annual updates of local plans will be far less costly than the initial planing effort.

IMPLEMENTATION REVENUE SOURCE

- It is recommended that the General Assembly provide the financial resources needed to support and assist in the implementation of the Statewide Public Transportation Coordination Policy.
- It is also recommended that no one agency's existing funding source(s) be used to underwrite these costs.
- **THE ROLE OF THE SCDHPT AND ITS PUBLIC TRANSPORTATION DIVISION IN PLAN IMPLEMENTATION**
 - Adoption of Plan by SCDHPT Commission and support of Legislative Action.
 - Develop and issue policies in support of coordinated public transportation, in the spirit of interagency cooperation.
 - Serve as a member of the Interagency Transportation Coordinating Council (ITCC).
 - Designate no less than one staff member (from PTD Planning Section) to serve as the liaison and key staff for the Select Oversight Committee (SOC) and the ITCC.
 - Provide administrative support to the SOC/ITCC.
 - Administer Coordinated Public Transportation Assistance Fund.
 - Provide technical guidance in the development of local coordination plans.
 - Review local coordination plans and certify compliance with Statewide Transportation Coordination Policy for SCDHPT, PTD grantees.
