Lilly,

We do have emergency PIP grants, but the funds are very limited. If we awarded the funds the town would be required to make a 30% match of the \$4,000 total asked and we would pay the remaining 70% -- Honea Path would pay \$1,714 and the LGOA would pay \$2,286 for a total amount of \$4,000.

We receive \$79,000 monthly for a total of \$948,000 annually from the Bingo fund for PIP. We currently have a \$1,643,781 balance at the end of the 2017 fiscal year, but that money is committed for an old project and the six PIP grants awarded by Lt. Governor Bryant this spring. We are ok as long as all six of the new grants do not seek reimbursements early in the new fiscal year (grant periods are for two years and we took that into consideration when deciding who received funds.)

I think we are ok with the 70% share of the \$4,000 grant total. Either the town or Doug Wright would need to download the PIP application from our web site. The Appalachia AAA would be the actual grantee from the LGOA and Honea Path the fund recipient. The AAA is required to approve all PIP applications in its region before the LGOA would consider it. I've attached this year's PIP application to this response.

Since we awarded several grants this spring we need to be very mindful that we cannot over award and not have funds to cover commitments in the future.
