On behalf of Dwayne Wilson, Savannah River Nuclear Solutions President and CEO, and Ronnie Young, Chairman of Aiken County Council, you are invited to join us in celebrating the official opening of the Energy Materials Research Laboratory (EMRL), a facility that highlights the Savannah River National Laboratory's (SRNL) position as a national scientific and technical asset, and an important resource to the regional economy.

In 2006, Aiken County constructed the Applied Research Center (ARC), a state of the art laboratory facility with concentration in hydrogen and alternative fuels. SRNL moved many of its unclassified research projects into the facility to provide greater access to the private sector and encourage job creation. Through \$3,000,000 in private funding from Savannah River Nuclear Solutions (SRNS), who manages and operates SRNL, we have completed a 6,000 square foot expansion of the ARC facility.

This expansion will support growing SRNL research on advanced materials in support of areas such as nuclear energy, energy storage materials and systems, solar energy materials, materials for wind and marine energy systems and carbon dioxide capture. We would also note that a private company, Hadron Technologies, is finalizing arrangements to locate a research and development office in this facility; Hadron has licensed a very promising SRNL microwave technology, and is looking into manufacturing and commercialization opportunities.

This is an opportunity for us to call attention to a first-class science facility, and the successful partnership

between SRNS and Aiken County that has made this happen. The ribbon cutting is rescheduled for Monday, November 4, at 3 p.m., at the Applied Research Center located near the Savannah River Site.
