Subject: Re: Skip hoagland denied membership in SC chamber for no reason !

Ted: This email, which is being made public -- including to the press and the South Carolina Ethics Commission -- is in response to your rejection of my application to join the South Carolina Chamber of Commerce.

Please be advised, and advise the members of your Board, that I will be filing a formal complaint against you with the South Carolina Ethics Commission cced on this email and I will also explore a lawsuit or lawsuits against the South Carolina Chamber of Commerce and against you personally for the harm this will cause me and my company.

Ted, it is now obvious that you are a crook and nothing but a stooge for David Tigges and the other co-conspirators that serve on your Board and as your "Chamber partner cronies"

Just like David Tigges, the Hilton Head Island-Bluffton Chamber, the Beaufort Chamber, Myrtle beach Chamber and others in South Carolina, you are totally corrupt and have now become part of the growing conspiracy to silence me and damage my reputation as a successful businessman who has a 40-year, unblemished record in South Carolina. Seems SC chamber just can't stand the truth and facts about crimes committed by their crooked members who pay them memberships every year with our tax monies. I am sure once we email many of your corporate members these emails many will become embarrassed to be part of this corrupted non profit living off their members dues.

Even more important, I won the landmark FOIA court ruling against Bill Miles and the Hilton Head Island-Bluffton Chamber last February. And once the SC Supreme Court upholds that ruling, I expect that David Tigges and Bill Miles will end up in jail. They chose to fight a judge ruling versus comply and worse spend thousands of public monies and members dues to pay lawyers to remain secret and abuse our entire community.

They are already the subjects of major criminal investigations that are ongoing.

As for my reputation, no one has ever accused me of being dishonest or of committing any kind of unethical behavior or fraud. Those who do will be sued for defamation and in fact a Hilton head town employee will be sued for defamation by me. I have always been honest in my dealings and through my hard work, I have been able to build a global digital media company that operates and is recognized and respected worldwide. Not

many of your members can make such a claim with any credibility. My one asset Southcarolina.com which was going to be the member now seems to be the enemy of the SC chamber and its board. Amazing in its self how corruption works and can turn an honest person into the bad person with vicious lies. I would have liked to hear the board who voted if this even happened on what was said to reject my membership. I will in fact find out. On Hilton head we have no votes, just the one crook Bill miles decides who gets in or out and that depends on who does as he says and protects his theft of public funds.

And yet, for reasons that are not at all clear, you and your criminal co-conspirators -- most notably the totally corrupt David Tigges -- have chosen to reject my application to become a member of your organization. Ted certain you are not controlled like a puppet by David tigges ?

The fact that you even refused to give me any reason for the rejection tells me you are in fact nothing but a puppet for David Tigges and the other anonymous power brokers that pull your strings and oversee your agenda of secrecy, refusal of transparency and corruption.

I now consider Chambers of Commerce worthless in the 21st Century, with more and more business being conducted on the Internet. Google ,Facebook , LinkedIn to name a few. And as you know, I own ChamberofCommerce.com, southcarolina.com , Southcarolinachamber.comCharleston.com, Hiltonhead.com and other city.coms in SC and worldwide which have become a viable online alternative for businesses nationwide.

I applied for membership and was counting on your honesty and integrity. And was hoping your decision would be, based on my email exchanges and phone conversations with you positive. You now have clearly demonstrated that you are dishonest and totally corrupt and that is to bad for both of us and will be embarrassing for you and your family as this goes Public. I feel sorry for children to have a father that is part of leaving a harder more corrupt world for them versus better. You truly should be a shamed of yourself. Your wife probably already knows how worthless you are and is stuck with you.

You have now confirmed that you are indeed possibly the most corrupt individual I have ever had the misfortune to deal with in this notoriously corrupt state.

Do you even understand why a prominent Judge ruled in my favor on my SC FOIA lawsuit against one of your members the HHI Chamber and the crooked 400k salaried Bill Miles and thief of public funds on every count in my lawsuit? Now you favor this crook as a SC Chamber member, versus an honest law bidding citizen? And worse, put the crooked lawyer on your board. Does it get any worse or corrupt than this?
