SENATE JUDICIARY COMMITTEE AMENDMENT

4/5/11

On July 1, 2011:

- (1) A Department of Administration is created headed by a director appointed by the Governor with the advice and consent of the Senate as provided in Section 1-30-10(B)(1)(i).
- (2) The following entities **ARE TRANSFERRED** from the Budget and Control Board to a Department of Administration:
 - (a) General Services (but not until a memorandum of Understanding is reached with the legislative and judicial agencies)
 - (b) Human Resources (except that any additions or amendments to the State Human Resource Regulations must be submitted for approval to the State Budget and Control Board)
 - (c) Information Technology
 - (d) Information Technology procurement
 - (e) State Engineer's Office
- (3) The following entities from the Governor's Office **ARE TRANSFERRED** to a Department of Administration:
 - (a) Office of Executive Policy and Programs, except for the State Ombudsman and Children's Services programs that are contained within this office
 - (b) Guardian ad Litem program ;
 - (c) Office of Economic Opportunity;
 - (d) Developmental Disabilities Council;
 - (e) Continuum of Care as established by Section 20-7-5610;
 - (f) Children's Foster Care as established by Section 20-7-2379;
 - (g) Veterans Affairs as established by Section 25-11-10;
 - (h) Commission on Women as established by Section 1-15-10;
 - (i) Victims Assistance as established by Article 13, Chapter 3, Title 16; and
 - (j) Small and Minority Business as established by Section 11-35-5270.
- (4) An Executive Budget Office is created in the Department of Administration.

(5) The following **REMAIN WITH THE BUDGET AND CONTROL BOARD:**

- (a) State Auditor;
- (b) Office of Research and Statistics, except for the employees required to provide revenue impact statements on proposed legislation and to support the General Assembly's budget writing duties who are transferred to the Legislative Fiscal Office;
- (c) Office of State Budget, except for the employees required to provide fiscal impact statements on proposed legislation and to support the General Assembly's budget writing duties who are transferred to the Legislative Fiscal Office;
- (d) Retirement Division;
- (e) Employee Insurance Program;
- (f) Procurement Division, except for the Information Technology Procurement Office and State Engineer's Office that are transferred to the Department of Administration;
- (g) Insurance Reserve Fund;
- (h) Board of Economic Advisors; and
- (i) Confederate Relic Room.

(6) The following **ARE TRANSFERRED** from the Budget and Control Board to the Legislative Fiscal Office:

- (a) the employees of the Office of State Budget required to provide fiscal impact statements on proposed legislation and to support the General Assembly's budget writing duties; and
- (b) the employees of the Office of Research and Statistics required to provide revenue impact statements on proposed legislation and to support the General Assembly's budget writing duties.

(7) The State Energy Office, including Federal grants authority, **IS TRANSFERRED** from the Budget and Control Board to the Office of Regulatory Staff.

(8) The South Carolina Infrastructure Facilities Authority, Office of Local Government in support of the local government loan program, and State Revolving Fund in support of water quality projects **ARE TRANSFERRED** from the Budget and Control Board to ~~DHEC~~.

- (9) The Joint Strategic Technology Committee, from a budget proviso, is codified to review the Statewide Strategic Information Technology Plan prepared by the Department of Administration.
- (10) The committee amendment **DOES NOT INCLUDE** the following that are in the House-passed version of the bill:
- (a) Legislative Oversight;
 - (b) transferring the Continuum of Care to DMH;
 - (c) transferring Small and Minority Business to the Secretary of State.
- (11) The committee amendment **ADDS**:
- (a) an Office of State Inspector General is created, effective January 1, 2012 ; and
 - (b) the duties of the Hunley Commission are transferred to and devolved upon the Navy Base Museum Authority.
- (12) The committee amendment provides that:
- (c) in 2015, the Legislative Audit Council must conduct a performance review of the provisions of this act;
 - (d) by January 15, 2012, the Code Commissioner must report all code references and cross-references which he considers in need of correction or modification as affected by this act;
 - (e) this act takes effect July 1, 2011, except that the State Inspector General provisions are effective on January 1, 2012; and
 - (f) the General Assembly shall undertake a joint oversight review investigation of the Department of Administration during the department's 5th year of operation.
